Motion of "No Opposition" to an Unincorporated Parcel Improvement for a Personal Aircraft Landing Strip

Motion by Chris Vaughn, seconded by Tim Dell to hold 'No Opposition' to improving a parcel in unincorporated Kane County, Village of Lily Lake planning area, with a landing strip for a personal aircraft. Mike Curtis, requestor, presented his plan to install a grass landing strip about 1000 ft. long on a parcel located at the west end of Read Road. He is asking for a letter of No Opposition from both Lily Lake and Virgil to present to Kane County for approval before he purchases the property. Landing strip is for a small personal recreational plane with no plans to provide commercial services or a teaching facility. He may bring his other small "stunt" plane to that location from time to time. Fueling questions and lighting for the airstrip were brought up. Tanks similar to farm equipment fueling tanks may be used or a trailered tank of around 400 gallons could be used. No lights will be used on the strip. Voice vote, motion passed unanimously based on the conditions discussed. Clerk will write a letter of No Opposition for Mr. Curtis.
