**REQUEST FOR RECORDS:**

SOMETIME IN ABOUT 2002, THE SOAH ALJ TOOK THE ACTION OF REVOKING THE INSURANCE LICENSES OF PHILLIP DEBBS MORRIS SOLELY ON THE STATEMENT OF AN ATTORNEY FROM THE TDI SOLELY ON THE STATEMENT THAT PHILLIP DEBBS MORRIS HAD FAILED TO COMPLY WITH THE COMMISSIONERS ORDER REQUIRING HIM TO MAKE "RESTITUTION." THIS ACTION WAS TAKEN AT THE VERY TIME PDM WAS INVOLVED IN A CRIMINAL CASE AS DEFENDANT OVER THE VERY SAME ISSUE WHICH WAS ALSO BROUGHT BY THE TDI. THE CRIMINAL CASE WAS DISMISSED WITH PREJUDICE IN AUGUST, 2003 DUE TO A CIVIL RIGHTS VIOLATION BY THE STATE OF TEXAS

WE REQUEST (1) THE NAME OF THE INDIVIDUAL WHO SPOKE WITH OR PRESENTED ANY EVIDENCE WHICH LED TO THE REVOCATION OF THE LICENSES (2) ANY DOCUMENTS OR RECORDS OF THE CASE IN WHICH THE LICENSE WAS REVOKED (3) THE NAME OF THE ALJ WHO ACCEPTED THE EVIDENCE AND APPROVED THE LICENSE REVOCATION (4) REVERSAL OF THE REVOCATION ORDER.
