State News Updates

April 2, 2020

- Governor Cuomo held a press conference at 11:30 PM and provided the following information:
 - o 92,381 total positive cases:
 - Every county now has positive cases according to the Department of Health.
 - 13,383 currently hospitalized.
 - 3,396 ICU patients.
 - 7,434 discharged.
 - o Deaths up to 2,373 up from 1,941, and all trend lines (hospitalization, intubations, ICU patients) all still going up.
 - The apex in the curve is different depending on the model (from 7 to 30 days), but the Governor believes it will be towards the shorter end.
 - Available staff is a problem that:
 - Upstate staff will be going downstate where needed.
 - 21,000 out of state health care officials have volunteered to help in New York.
 - 85,400 volunteers in total, who are being deployed to hospitals that need it.
 - Supplies is an ongoing challenge:
 - Asking hospitals to donate supplies to a central stockpile where the State can distribute them to where they are needed.
 - Sill looking for more supplies and those interested in helping can contact the following:

 - Released 400 ventilators to NYC, and 200 to Long Island and Westchester.
 - At the current burn rate, there are enough ventilators in the stockpile for six days.
 - Utilizing extraordinary measures to address the ventilator issue:
 - Know where they all are and will shift them where they are needed.
 - Ending elective surgeries will increase the supply.
 - Using anesthesia machine ventilators.
 - Splitting ventilator tubes.
 - Utilizing and converting BiPAP machines, and purchased 3,000 from Philips in Pittsburgh (750 machines arrived yesterday).
 - Still looking to acquire more ventilators.
 - Opening health care exchange enrollment period through May 15 (additional 30 days).
 - o Through June 1, 2020, consumers and businesses experiencing financial hardship due to COVID-19 may defer paying premiums under individual and small group health insurance policies.
