Pursuant to State of Nevada Executive Department Declaration of Emergency Directive 006, the Round Mountain Town Board meeting will hold public meetings via teleconference. The Town Board Chairman will open public comment periods by announcement. Commenters must press 5 * on the telephone keypads to notify administrators they wish to speak. Commenters will be called upon by name. Access will always be available during the meeting.
