HUNTER'S RUN CONSERVANCY DISTRICT SPECIAL REGULATIONS, GUIDELINES & EXEMPTION FROM LIABILITY

Special Regulations

- (1) It shall be lawful to hunt game birds and game quadrupeds in the area designated on the attached Hunting Area Map on file at Hunter's Run Conservancy District. The official Hunting Area Map indicates areas of the property that are open and closed to hunting and any restrictions on hunting on the property. The area(s) of the Property where hunting is allowed is hereby designated a "Public Hunting Area." Persons who have obtained the proper state and federal license(s) shall be permitted to access and hunt all legal species with archery equipment or shotgun in accordance with the state and federal statutes and wildlife orders.
- (2) No person shall be unlawful to engage in practice shooting or shall any person possess or discharge any rifle, pistol or revolver; or a shotgun firing a single projectile.
- (3) The Public Hunting Area at Hunter's Run Conservancy District Structure #4 shall remain open for persons actively engaged in hunting or fishing at all times unless posted otherwise.
- (4) Baiting is not permitted on the Property. Fishing is permitted. The hunting of waterfowl, and the bow hunting of deer are permitted. However, no other types of hunting are permitted.
- (5) Permanent hunting stands or blinds are not permitted on the Property.

General Public Hunting Area Regulations

Except as otherwise specified, all other state and federal wildlife orders and statutes shall be applicable in any public hunting area managed by Hunter's Run Conservancy District.

Safety Zones

No person shall at any time take, hunt, trap, kill, pursue, or shoot at any wildlife and/or wild animals by any means within 300 feet (See Attached Map) of any residence, barn, shelter house, parking lot, building or other structure or shoot on, from, or across any road or driveway.

<u>Conditions:</u> 1) Respect the rights of the Landowner; 2) Be careful in the handling of firearms; 3) Do not damage fences, buildings or other property; 4) Do not litter the area or dump any rubbish; 4) Obey all hunting laws and regulations of the Division of Wildlife; 5) This free permit is only valid on the lands of the issuing Landowner and only for the days specified.

<u>Exemption from liability to recreational users pursuant to O.R.C. 1533.181:</u> (A) No owner, or lessee, or occupant of premises: (1) Owes any duty to a recreational user to keep the premises safe for entry or use; (2) Extends any assurances to a recreational user, through the act of giving permission, that the premises are safe for entry or use; (3) Assumes responsibility for or incurs liability for any injury to person or property caused by any act of a recreational user.
