BUYER AGREES TO THE FOLLOWING TERMS

- 1) Kittens/Cats being purchased as a **pet**:
 - a) Will not be used as a breeder.
 - b) Will be altered (spayed/neutered) no later than nine (9) months of age.
 - c) A certificate of altering must be sent to seller (MA MELODY'S) at which time seller will provide buyer with CFA registration papers.
 - d) Failure to have a cat altered by the stated age will result in forfeiting registration paper by the buyer to the seller (MA MELODY'S).
 - e) Will not be declawed.
 - f) Will not be permitted outdoors except for a cat safe enclosure.

- 2) Kittens/Cats being purchased as a potential **breeder/show**:
 - a) Will be shown in at least one (1) recognized association; CFA or TICA are two preferred associations.
 - b) Will be bred to registered, pedigreed Maine Coon cats of similar quality.
 - c) Are preferred not to be bred until one (1) year of age. (To allow female breeder to mature first).
 - d) Females are guaranteed to be fertile. If she fails to conceive after three (3) breedings and the male is proven fertile, the female will be replaced. Buyer return shipping at buyer's expense. If female is returned, seller (MA MELODY'S) will pay shipment on replacement.

- 3) Buyer agrees that the kitten/cat will receive good care, proper food, and vet visits are to never be neglected.

- 4) Seller kitten/cat will be healthy and vaccinated for the appropriate age of the kitten/cat.

- 5) Buyer agrees to have the kitten/cat examined by a licensed veterinarian within seventy-two (72) hours (excluding weekends and shipping) after possession of the kitten/cat. If the kitten/cat is found to be in ill health, the buyer must notify the seller (MA MELODY'S) immediately. Upon receipt of written documentation from the veterinarian, MA MELODY'S cannot be held responsible for the overall health of the kitten/cat. In the unlikely event that a kitten/cat is diagnosed with a genetic disorder and expires within a year of purchase from said genetic disorder, the buyer must be eligible for a replacement kitten/cat upon notification to MA MELODY'S within twenty-four (24) hours of the animal's death. A full veterinarian necropsy must be completed on the expired animal, and copies of the necropsy report and all medical records pertaining to the animal must be submitted to MA MELODY'S for review. Only then will a replacement kitten/cat be provided.

- 6) Buyer agrees that the kitten/cat will not be sold or given away without the written permission of the breeder, MA MELODY'S.

- 7) A non-refundable deposit of \$200.00 is required to hold a kitten/cat. The balance is due when the buyer takes possession of the kitten/cat. If shipping the kitten/cat, the balance will be due prior to shipping.

- 8) If the kitten/cat is being shipped, the buyer is responsible for all shipping costs.
- 9) Should the buyer fail to honor the terms of this contract, the kitten/cat will be forfeited to the seller (MA MELODY'S) without compensation.

We, the undersigned, consider this document legally binding. All parties must initial all changes.
