1199. Discussion and Agreement of the proposed budget items for year 2016/2017.

The Clerk had, with the agenda, distributed to each Member copies of his budget estimate to 31 March 2016 and for the year 2016/2017.

Following a brief discussion it was proposed by Cllr. Wright, seconded by Cllr. Prime and unanimously agreed that the following Budget figures be agreed for the year 2016/2017:

- iv.. Capital Projects..£7,000.00

1200. Requirements under the Audit Regulations.

i. <u>Appointment of Responsible Financial Officer (RFO).</u>

Proposed by Cllr. Abbott, seconded by Cllr. Wright and unanimously agreed that the Parish Clerk continue as the Responsible Financial Officer for the year 2016/2017.

ii. Appointment of Internal Auditor.

Proposed by Cllr. Abbott, seconded by Cllr. Prime and unanimously agreed that Mrs. Ann Clarke be reappointed Internal Auditor for the year 2016/2017.

1201. To set the Precept for the year 2016/2017.

Taking the budget figures at item 1199 above, the proposed budget for 2016/2017 is £13,572.00, excluding £7,000.00 from reserve funds for any Capital Expenditure. Less the estimated BDC's Localism Fund Grant and Street Cleaning Grants of £1,840.00 and £1,753.00 respectively the estimated budget expenditure for 2016/2017, therefore, is £9,979.00.

Proposed by Cllr. Abbott, seconded by Cllr. Wright and unanimously agreed that a Precept amount of £9,450.00 be levied for the year 2016/2017.

This gives an estimated Band D equivalent Council Tax of £36.23 £0.05 less than for 2015/2016.

This Budget and Precept was **recommended for final approval** at the next Parish Council meeting on 5 January 2016.
