

ACCEPTABLE DOCUMENTS LIST STANDARD DL-ID CARD

To prove identity, you must show proof of the following five elements:

1 - Full Legal Name*; 2 - Date of Birth; 3 - Legal Presence in US; 4 - Social Security Number; and 5 - Ohio Street Address

To prove an element, the element must be contained on the document. One document from this list may be presented for a duplicate or renewal issuance (does not apply to Non U.S. citizens).

Acceptable documents that contain a current Ohio street address are acceptable to prove address.

- Certified Copy of a Decree of Divorce, Dissolution, or Annulment of Marriage**
- Certified Copy of a Court Ordered Name Change

**NOTE: If you have had more than one marriage, you may need to bring documentation from each marriage and/or divorce to connect your birth certificate, passport or USCIS documents to your current legal name. Permanent Resident Card (Form I-551) must show current legal name.
