State News Updates

June 4, 2020

- **Governor Cuomo held a press conference at 11:30 AM and announced the following:**
 - Total hospitalizations at 2,849 on June 3.
 - Total deaths increased by 52 on June 3.
 - Averaging 50,000 tests per day, and will expand the State’s testing criteria to all those who have joined recent protests.
 - Current positive rates:
 - Long Island: 2%
 - New York City: 2%
 - Western New York: 2%
 - Capital Region: 1%
 - Reopening:
 - Need to proceed with caution as other states saw rising cases when they reopened.
 - New York City is still anticipated to open for Phase One on Monday (June 8).
 - Outdoor dining for Mid-Hudson next Tuesday, Long Island next Wednesday.
 - Allowing drive-in and drive-thru student graduations and will keep evaluating going forward.
 - Medical schools to open statewide on June 22.
