
Hogan Creek Watershed Priority Areas



Attention Hogan Creek Landowners:

Have you ever had a need to correct a natural resource problem on your land but just couldn't fit it into your budget? If your property is located in the Hogan Creek watershed area, budgeting for conservation just became a little bit easier!

The Hogan Creek Watershed Project, with assistance from the Indiana Department of Environmental Management (IDEM) and the Dearborn and Ripley County Soil and Water Conservation Districts (SWCDs), has secured funds to help you put conservation on your land.

Cost-share funds will be available through April 2021 and will address resource concerns identified in the Hogan Creek Management Plan. Funds from this project came from an IDEM 319 grant, sponsored by Dearborn County SWCD, and will be available for 3 years or until money runs out.









Funding Process

When a landowner shows interest in the cost-share program, his property will be checked first to insure it is located inside the Hogan Creek Watershed boundaries. Then a field visit will be conducted by the Watershed Coordinator and the Cost-share Ranking Sheet will be completed. Landowners located in the high priority area - Tier 1 who rank "High" will be funded first. If money is still available after the first year, landowners who rank high in the high priority area - Tier 2 will receive funding. - See Priority Areas on back sheet

Implementing Practices

All practices must be completed according to NRCS (Natural Resources Conservation Service) FOTG (Field Office Technical Guide) specifications. Many practices are engineered and must be installed according to the designs provided within 1 year of receiving the designs. All practices and paperwork must be completed and submitted by April 2021. Payment is a reimbursement and usually takes 4-6 weeks after payment package is submitted. Landowners are responsible for paying for all materials and contractors.
