## Privacy Policy

1. The Canadian PPE Network (Also referred to as "The Network") only collects personal information when you give it to us voluntarily, for example, by filling out a form or survey.
2. We may gather information about traffic on our web site so that we can continue to develop the site to better suit your needs. This does not include personal information about you, but includes information about your visit on the site such as:
  - The name of your Internet service provider, its IP address and the name of your provider's service.
  - The length of each visit.
  - The number of requests per visit.
