ORDINANCE No. 9/17/18 (2018)

An Ordinance Establishing Seasonal Weight Limits

The Town Board of the Town of Farmington, Waupaca County, Wisconsin do ordain as follows:

Section 1: As per State Statutes 348.16 & 346.17, the Town Board has the authority to impose seasonal weight limitations on any such highway or portion thereof to promote the general health, safety and welfare and to assist in the protection of roadbeds which would likely be seriously damaged or destroyed in the absence of such limitations.

Section 2: The following seasonal weight limits shall be in effect for the period of time to coincide with the placement of weight limits on county roads by the Waupaca County Highway Department Commissioner.

Section 3: There is hereby imposed a weight limitation of six tons per single axle and ten tons per tandem axle, effective upon appropriate posting as provided below on the designated roads.

Section 4: The seasonal weight limits shall apply to the following roads:

Anderson Rd from State Rd 10 to Larson Rd

Bartel Rd from Haase Rd to Cty Hwy Q

Cobbtown Rd from Riverbend Ln to Townline Rd

Erickson Rd from State Rd 10 to Cty Hwy Q

Foley Dr from Floistad Rd to Cobbtown Rd

Golke Rd from Cty Hwy Q to Edminster Rd

Grenlie Rd from Cty Hwy Q to Foley Dr

Haase Rd from Oakland Dr to Cty Hwy Q

King Rd from State Rd 22 to Cty Hwy QQ

Larson Rd from Brainerd Dr to Cty Hwy Q

Morgan Dr from State Rd 10 to Cobbtown Rd

Nelson Rd from Ware Rd to Oakland Dr

Oakland Dr from Larson Rd to Smokey Valley Rd

Pryse Dr from King Rd to Cty Hwy QQ

Smokey Valley Rd from State Rd 49 to Town of Scandinavia

This also includes all Chain O'Lakes roads and those in King area and the following subdivisions: Berkshire, Covered Bridge, Oak-Popple-Hillcrest-Birch Haven, Silver Lake and Woodridge.

Section 5: The Town employee shall erect signs as required under s.349.16(2) Wis Stat. prior to the effectiveness of any restrictions imposed under this ordinance.

Section 6: All of the above roads are designated to be a class "B" highway.

Section 7: No person may operate any vehicle on the above-noted highways in violation of the above-noted weight limits without a written permit issued by the Town Clerk at the Town of Farmington Hall.

Section 7: Any violations of this ordinance shall be subject to penalties under s 348.21

Section 8: This Ordinance shall take effect upon passage and publication according to law.

The town clerk shall properly post or publish this ordinance as required under s. 60.80, Wis Stats.
