Roofers have been working on the pool. Insurance company is still working on getting an HVAC technician out here. Visited by a structural engineer and have not received his report back yet. Still waiting on a mechanical engineer to come take a look at the equipment on the inside of the pool. Friday Admin staff will be meeting with POOL/PACT to look at the service plan for the year that entails what training the employees may need. Please complete Open Meeting Law training. Fire Department and Maintenance will be working towards the firework show; fireworks have been delivered, and maintenance will be out there grading the dirt mound.

Spivey asked if we're looking at opening the gym for more hours as most people work shift work and are not able to go. Rebecca Hansen explained that we are following the Governor's mandates as close as we can and the County's mandates, most gyms that are open around the clock are staffed. The community is welcome to call Recreation during the day to see if they are at capacity, 6 in the weight room and 6 in the cardio, and if not, they can do a drop in appointment. Spivey asked if we can look into that we budgeted to hire people for the pool and hire two people to do the gym and do temp checks and sign people in and out.
