PROVISIONS FOR RELEASE OF PAYMENTS

- The total amount of funds released will be based on the performance of installation of proposed best management practice (s).
- No funds will be released until installation and inspection by Lenawee Conservation District Staff.
- Funds are dispersed on a quarterly basis after practice inspection, review of bills and receipts and approval by the DEQ. Quarterly dates are October, January, April, July.
- It is important that inspections and review of bills and receipts be completed a minimum of two weeks prior to end of quarters.
- Any BMP installed by the Lenawee Drain Commission will be billed directly to the Lenawee Conservation District to pay the Lenawee Drain Commission.
- Signed Agreement between Landowner/Farmer and Lenawee Conservation District regarding who pays for BMP's and maintains them when installed within Lenawee Drain Commission right of way.
