## Executive Summary

Littlefield Consulting was retained to conduct a public opinion survey in Monterey County, California. The survey was put into the field on Monday, April 18, 2016.

423 voters responded to the survey, $N=423$. The margin of error (MOE) is based on a Monterey County, California voter population of 76,951 registered voters and $\mathrm{N}=423$.
The MOE for the entire County is +/- 4.8 and the confidence level is $95 \%$.

- The margin of error for Board of Supervisor District 1 is $+/-10.9$.
- The margin of error for Board of Supervisor District 4 is $+/-7.3$.
- The margin of error for Board of Supervisor District 5 is $+/-5.4$.

There was an oversampling of females and seniors and an under sampling of males and younger voters.
