## EMPLOYEE WAGE NEGOTIATIONS

The Foreman submitted his expectations of wages for 2011 for both his staff and for himself to council. He asked for there to be a division of levels/wages for the different job descriptions. He proposed that there be three levels of jobs for the outside staff. The first being "Senior Operator" who would be the permanent full time grader operator, the second being "Operators" who would be the seasonal grader operator and gravel hauler, and the third being "Mower/Maintenance" who would be the seasonal mower operator/maintenance people. Each level shall be paid according to level of responsibility. Kirk requested that the Senior Operator be paid \$24/hr, the Operators be paid \$21/hr, and the mower/maintenance employees not make more than \$20/hr (one to make \$20/hr and the other to remain at \$19.43/hr as a raise was already received for 2010). The foreman asked for his wage to increase to \$65,000/year (roughly \$27/hr). Each employee's years of service and hours worked for 2010 were also noted.

The Administrator asked that the assistant be increased to what the outside staff are making as she has 10 years of experience and was paid a higher wage two years ago when she was hired on a temporary fill in basis. The Administrator explained that RMAA set the wage increase for 2011 to be at 2.8% and requested a raise of 4% (\$58,708).

The Administrator presented council with a spreadsheet of comparison of wages for RMs 1, 2, 3, 4, 5, 31, 32, 33, 34, 35, 36, 61, 63, 64.

Both the Foreman and the Administrator were asked to leave the room so that council could discuss wages.
