

AUXILIARY DELEGATES TO DISTRICTS

Review Sec. 301 and Sec. 503

Members must be a member in good standing in the Auxiliary to which they are being elected.

Delegates and Alternates serve for one year – from election to election.

Delegates and Alternates shall function at the convention and any District meeting where voting is called for.

Delegates shall be elected at Auxiliary meeting not less than 30 days prior to the District convention. **ARIZONA – DUE TO AUXILIARY AND DISTRICT MEETINGS AT DIFFERING TIMES, DISTRICT DELEGATES SHOULD BE ELECTED AT THE MARCH MEETING.**

PER DEPARTMENT BYLAWS – The Auxiliary will elect one (1) Delegate and one (1) for every ten (10) members in good standing on the date of election.

Example - The night of the meeting, the Auxiliary has 185 members. The Auxiliary will elect 19 Delegates and 19 Alternates. Delegates and Alternates do not need to be present to be elected.

When electing Delegates and Alternates, consider which members attend District meetings. Members that do not attend Auxiliary meetings but do attend District meetings, should be considered for election as Delegates or Alternates.

The following members have their own vote at District convention or meetings:

- The National President or any Past National President (in good standing in an Auxiliary in the District)
- The Department President and any Past Department President (in good standing in an Auxiliary in the District)
- All District elected and appointive officers of the District
- All Past District Presidents (in good standing in an Auxiliary in the District)
- Each Auxiliary President throughout the District. If the President is absent the Sr. Vice President may cast that vote, or if President and Sr. Vice President are absent, the Jr. Vice President may cast that vote.

Those members shall be listed at the bottom of the Auxiliary Delegate list. Those members should be considered for election as Alternates and listed as such.

Those members who have their own vote as officers, etc. and who are also an elected Delegate/Alternate shall notify the District Secretary prior to the meeting how they wish to vote – individually or as a delegate.

There are no Delegate Fees for DISTRICT Delegates.

Auxiliaries in arrears or not meeting the following requirements shall be deprived of Auxiliary representation at the District convention and meetings for which those dues are in arrears:

- In arrears for District Dues
- In arrears for any financial obligation to the National Organization
- Failure to have the Office of President and Treasurer bonded
- Failure to make quarterly audits

It is up to the District President to confirm that Auxiliaries in the District are entitled to representation.

LISTING THE DELEGATES AND ALTERNATES IN ALPHABETICAL ORDER WILL SAVE TIME IN CONFIRMING MEMBER STATUS AS DELEGATE OR ALTERNATE OR OFFICER.

The Auxiliary Secretary will immediately send the District Delegate List to the District Secretary.
