NCCLC Youth Forum Proposal

Purpose

- To provide an opportunity for young people to express their concerns regarding various issues that affect their ability to advance into successful adult life
- To encourage young people to become involved in Community activities and enable them to address negative issues that impact their educational and social environments in a responsible way
- > To enable youth (Ages to be determined by committee) to express their commitment to Community values

Taking into account the above, as well as the Goals and Objectives of the NCCLC, the Forum will be based on four fundamental elements:

- Young people as the major and genuine stakeholders
- The Forum serves as a platform for sharing ideas and viewpoints, and will be attended not only by young representatives of youth groups across the county, but also by experts and community leaders who will guide and moderate the various working sessions.
- Emphasis will be placed on identifying solutions that will enhance the participants ability to problem solve; therefore, various working groups will be set up to address all relevant issues.
- There will be follow-up activities in the community to ensure continued efforts to address revelevent issues that are identified during the forum.
