## 7.0 Reports of Committees

## 7.1 Thank You – Tristina

To say thank you and as a token of our appreciation for being the Blackfalds Farmer's Market Manager these past years Trish presented to Tristina a \$100 gift certificate for Family Foods and a \$25 gift certificate for Subway.

# 7.2 Future of Farmers' Market

The season's last market was finished with 5 vendors and about 30 customers while the season started with 25 vendors and 200 to 300 customers.

The change to a different time and day of the week as well as having the market outside did not have the desired effect.

Very frustrating for Tristina as market manager is the fact that Blackfalds residents are saying on Facebook not to go to the Blackfalds Farmers' Market.

The special markets at the Community Hall seem to be doing much better. The October market attracted 30 vendors and 200 customers. Special markets to be considered are during Blackfalds Days, Winterfest in February, Mother's Day and during the oct/nov/dec period.

To be eligible as a Farmers' Market the Ag Society needs to hold at least 8 markets a year. Not clear is if the 8 markets have to be held consecutively.

Tristina makes a motion to abandon the Market as of December 31, 2013. Kylie suggests to make sure the 8 markets have to be consecutive before we take this step.

If we don't go ahead with the Farmers' Market this coming season we need to find another agriculture related event to sponsor/organize so we don't lose our yearly grant of \$17,500. Ideas brought forward include: petting zoo, continuation of the plant-a-planter program, barrel race or other horse event, community gardens (e.g. provide dinner during harvest; sell harvest at a market), canning/preserving course, food safety course (Alberta Health Services).

Les, Carol, Trish and Mat volunteered to go to Agri-Trade to see if there are people we can network with and come up with new ideas for an agricultural event. Agri-Trade is from Nov. 6-9 at the Westerner in Red Deer.

Tristina was able to find the grant eligibility requirements for Farmers' Markets: Minimum of 10 markets, at least 2 hours per market day with a minimum of 10 vendors of which 8 must be selling homemade products.

# 8.0 Unfinished Business/Updates

# 8.1 2014 Budget

Trish calculated what the expenses were for last season and it turned out to be almost \$37,000. A detailed list of expenses is shown on the agenda for this meeting. Big ticket items are ACCA Youth Camp, naming rights for the Field House, Blindman 4H Club and expenses related to legal requirements such as insurance, audit and membership fees. Trish mentioned that we tend to approve funding requests ad hoc. The Ag Society needs to decide what is important.

Our policy is to sponsor up to 10 kids each year to go to the ACCA Youth Camp. This includes bus fees and other fees. Tristina proposes to change the policy to sponsor up to 5 kids including all fees. Carol says the Youth Camp has a huge impact in kid's lives. It teaches them skills that are beneficial in their future lives. Instead of minimizing the number of kids we should perhaps consider cutting the donations of for example the 4H club.

Maybe we should be looking into fundraising possibilities like organizing a Bull Buster or a Grey Cup Party?

After some discussion we tentatively agreed to donate a maximum amount of \$1000 per year for non-agricultural events on a first come-first serve basis.

Trish proposes to make a budget list for next meeting so we have a more clear understanding on where the money is coming from and where it all goes.

## 8.2 4H Funding Request

The Ag Society received a \$6,585 donation request from Blindman 4H Club. Trish talked to Tamara about their Alberta Gaming and Liquor Commission (AGLC) License. Tamara indicated that the 4H Club is an eligible recipient even though the club does not have an AGLC License.

Motion made by Carol to defer this item to the November meeting. CARRIED

# 8.3 FCSS Meeting – Children's Charter

Dena went to the meeting. Total attendance was 10 people from different agencies and elementary school. The goal was to get different ideas what children want to see, to try to equalize the playing field and how to reach families in need. Trish thanked Dena for attending.
