Let's all understand that the above list of complaints is just that, complaints. Some are made by Shareholders, some by producers, some by other interest holders, some by vendors, and many are by BIA employees. But, they are all filed with the enforcement division of the US Department of Justice. The fact that the investigators have even accepted these complaints for further consideration should tell us that this is serious business. If anyone lodging a complaint with, or being interrogated by, a Federal Investigator is proven to be deliberately lying or providing misleading information, that person could be facing huge fines and possibly some time in a Federal penitentiary. I would think that the investigators surely make this clear at the beginning of each interview. This tends to make me believe that these are not frivolous accusations made by a bunch of disgruntled individuals simply set on revenge. These complainants are honest, hardworking people who have witnessed and/or experienced many bad things being made common practice at the Osage Agency in Pawhuska. They just can't all be wrong!

I would be surprised if further action is taken on each and every complaint filed, but the fact that the Superintendent has been relieved of her command as of January 7, 2013 seems to indicate that they have found something, maybe many things, very wrong within the system and this may be the first of many corrections they will be making. And this was done based on one of the first preliminary reports coming out of the investigation. It could take a year or more to resolve the accounting issues to everyone's satisfaction. I am told that the accounting problems began to surface in late 2006. They may need to go back even further than that. One thing for sure, this will be a long, painful process for both the accused and the complainants.
