#### TREASURER'S REPORT By Pam Bowden, Treasurer

Financial success should not be measured by a profit and loss statement, but by the outreach and

impact LCN has in the community. It's not about how much we made, it's about how much we gave and the influence it had on individuals and the local area. I have been approached by several community leaders and thanked for the changes and outreach LCN has made. Our impact has been noticed and appreciated.

Here is our 2012 "Impact Statement".

- ✓ The Mardi Gras fundraiser profit was \$5,950. That along with private scholarship donations of \$18,378, resulted in \$24,328, making it a record breaking year with 22 scholarships awarded.
- √ The Spring Fling Style Show, which funds our Veterans Thank You event, had a profit of \$1,535.
- √ The Founders Day city donation to LCN and Savor the Flavor event resulted in \$3,516 profit. These funds helped cover the CASA and Families Christmases with \$1000 remaining in the account. This benefit was possible due to our 501(c)(3) status.
- ✓ 3 Hog Night had a profit of \$8,018. These proceeds have been distributed between Good Samaritans and Alba Food Pantry. Good Samaritans has already installed new AC/Heat units, new doors, and locks throughout the building. Alba Golden Food Pantry has been able to purchase food which kept them open in November and set a record month for them with 75 families being fed thanks to our donation. It would not have been possible without it.

Thank you, LCN members for the time, talents and treasures you contributed in 2012. Your "impact" was off the charts!

This will be my farewell article in the newsletter. I am very proud to be part of an organization with as many caring, charitable, and classy ladies as we have. Thank you for allowing me to be on the board and able to hand out the checks to the organizations and individuals we support. It has been a blessing for me and now I proudly turn the Treasurer reigns over to Shirley Haskins. Thank you again.
