Treasurers Report: Balance of \$6,395. Paid \$100 out to 501c3 process. Received \$1,000 from Wright County Parks for weed control. Triathlon support to be addressed by Joe Bayer.

Membership: Total of 81 members of a possible 130. Will send a dues letter request to all after the 1st of the year and then include reminders in the newsletter and e-mails. Will include a list of benefits all homeowners are receiving because of the lake organization. List of members will be included in the next newsletter.

Welcome committee: We hope to have Director Olson head up a committee to see that all new homeowners are welcomed and informed of the lake association and its goals. This welcome-call could include a gift and information helpful to our new neighbors.

Newsletter: Chair Sedey has delivered the mailing labels and paper should be ready to go. A review of the CedarLake newsletter by the board is now recommending to the newsletter staff that a Committee Update page be included in our next issue. We will ask the editor if this is a feasible request and how to go about gathering the needed info. Local advertising in their paper was discussed.

Website: New pictures and info have been added to the site. The newsletter will also be found on the site. Please forward any lake related news to Maggie.

501C3: Application is being processed by the State. Process could take up to 6 months.

Weed treatment program: We have contracted with Lake Restoration for a 10 acre treatment. The west end will be the primary site with the County Park troubled areas being the secondary site. This has been our two treatment areas for the past 7 years. Up to \$5,000 is budgeted for this years treatments. Treatment can begin when water temp. reaches 55. It is a goal that in the near future we will be able to treat the total 20 acres allowed by the DNR.

Annual membership meeting: May 18, 9 a.m. in the basement of the park pavilion We will serve coffee and rolls. We hope to have a rep from the County Parks address the group. Merle Anderson will be invited to come and speak to watershed issues.
