(Initial please) 1. I acknowledge the fees will be deducted on the 1st of each month. If you start late in the season, we will break down any **additional fees** into monthly payments that will be due on the 15th of each month. The payments for additional fees are separate from the regular monthly tuition that is due on the 1st of each month.

(Initial please) 2. CSC reserves the right to submit an electronic draft additional times, should the funds, from the card listed below, return as insufficient. A \$25.00 fee will be incurred for payments returned for insufficient funds.

_____ (Initial please) 3. I acknowledge that if the 1st of the month falls on a weekend or holiday, that my card will be charged on that Friday prior to the weekend or holiday.

_____ (Initial please) 4. I acknowledge that if my card cannot be successfully charged, a late fee of \$25.00 will be added to my account. I acknowledge that if my account is still not current after 7 days, my account will be placed on hold.

(Initial please) 5. I understand that if my child misses practice for more than 29 days, or decides to quit Corona Stars Cheer Competition program at any time from the acceptance dates to the end of the competition season, I will be charged a \$500.00 CANCELATION FEE for All Star Cheer. This fee will be deducted from this card given to the Corona Stars Cheer. If a card is not available or valid, the fee will be due by check or cash within 3 days of drop fee posting.

PARENT EXPECTATIONS

Challenging the coach or person in charge, by a parent will be automatic dismissal.

Negative Behavior will not be tolerated.

Do not post negative comments, routines, or music on message boards, Instagram, Facebook, or any other websites.

To make sure your child is on time and ready for practice at designated practice times.

Parents are to inform the front desk if their child is going to be late.

To stay informed. Check your email, monthly calendars, and any other handouts regularly. If you are not receiving emails or text messages, contact the gym immediately.

Parents are to fulfill any financial obligations ON TIME or risk expulsion from our team.

Parents are to support their children and their children's goals.

Parents are to example good sportsmanship, positive conduct, and professionalism at all competitions and practices

Parents are to hold children accountable for their actions. If there is an issue, encourage your child to speak to the coach, this only enforces and gives your child a sense of being heard and understood.

Other arrangements need to be made if a parent cannot stay for the duration of the competition.

Support the rules and encourage your child to abide by them.

Parents are not to yell into the gym or make contact through the windows or entrance.

Parents are to support our coaches. Our coaches have your child's best interest and safety in mind at all times.

Parents are to stay off the practice mat at ALL TIMES. Unless otherwise stated by the Head Coach.

There will be NO outbursts by the parents tolerated whatsoever. Grounds for dismissal.

If a parent or child decides to leave the team for any reason before the season is over (MAY 2019) the parent is responsible for paying a buyout fee of \$500.

<u>Under no circumstances</u> may a parent or CSC affiliates, falsely act as a representative of CSC for the purpose of securing accommodations, gaining entry to a competition, or for any other purpose.

No videos of routines, choreography and music are to be uploaded on any online site such as "You Tube" or "Face book" etc....

ATHLETE EXPECTATIONS

I will be on time to practice and dressed appropriately. (tight fitted clothing, cheer shoes, hair up with bow, NO jewelry)

I promise to give 100% at every practice.

I will not say "I Can't".

I will do my personal best to achieve all my goals.

Continual failure to be productive at practice will result in disciplinary action which is subject but not limited to suspension or dismissal.

Do not post negative comments, routines, or music on message boards, Instagram, Facebook, or any other websites.

I am responsible for finding out any information I may have missed.

My parent is not responsible for any assignments my coach gives me.

I will maintain the highest example of behavior. I will respect each other's personal space.

BULLYING (physical or verbal) will not be tolerated.

I will come to class ready to work and ready to listen to my coaches.

Each team member must be aware of the commitment he or she is giving to join a competitive team.

Each team member must be aware of the responsibilities he or she is taking on by joining a competitive team.

Each member must be willing to work hard and give 100% at all times.

The use of cell phones is strictly prohibited during practice! Any athlete observed by a coach talking, texting, or checking messages on cell phones during practice without the permission of the coach will have the cell phone confiscated immediately and returned to parents. Cell phones will be returned with strict reminders about this rule.

ABSENCES

<u>Attendance is crucial to team success</u>. Vacations and/or absences may result in athlete being replaced on their team. If your child will be out for any practice during the summer months only, please fill out a vacation form and turn it in to the front desk. All team members must hand in their summer vacation request forms 3 weeks into summer. If a notice is not handed in, that child may lose their competition spot and will sit out a practice for a day. All vacation slips, for the entire season, must be turned in prior to August 1st, 2018. After, August 1st 2018, a participant will only be excused for graded school activities or severe illness with a doctor's note. If you are requesting an excuse for a school activity, you must provide a flyer from the school along with the teachers signature, 2 weeks prior to the event.

Withholding your child from practice CANNOT be used as a form of discipline. This is unfair to the rest of the team. <u>Vacations are not</u> <u>permitted during competition season</u>, unless the gym is closed and the athlete has already cleared it with their coaches. Punctuality is a MUST. Arrive 10 minutes early to all practices, competitions, and functions.

EXCUSED ABSENCES: Contagious Illness with Dr. Note / Family Emergencies / School function that affects grade—a 2 week notice with school flyer must be given along with teachers signature.

<u>Choreography dates are mandatory, no exceptions</u>! Athletes who are not in attendance will not be choreographed into the routine and may be removed from the program at the discretion of the owner.

If you take the summer off, have a late start, or enroll in the middle of the 2018-2019 cheer season, you will be placed as an alternate until a spot is needed. **Summertime is an important time to learn new skills**!

<u>Competitions</u>—During each competitive season there will be a number of competitions that Corona Stars Cheer will plan on attending. This list will be handed out as soon as it is confirmed. Each team member that is going to a competition must have competitive fees paid before the deadlines. These deposits are due regardless of child's attendance to any of the competitions. All athletes will have deadlines for cheer routines it's important they know the material. We perform as a team so it's important that we are prepared for competition. Coaches will evaluate athletes on these deadlines. If they do not know the required material coaches reserve the right to, move, replace, or even suspend an athlete until the material is at the level of their team members. A discount or refund will not be issued due to quitting, injury, illness, vacation, camps, schedule conflicts, removal from the team, merging of teams, or any other reason. No practice can be missed TWO weeks prior to any competition. You will be charged a \$100 fee, and could result in athlete being removed from the routine and not competing. If any athlete doesn't compete at a competition, no matter the reason, they must pay an additional \$200 Competition Charge.

<u>Flyer Class</u>—This is a <u>mandatory class</u> for athletes who are flying in any stunt or will be anticipated as being flyers for the season, at the discretion of the coach. You are welcome to attend the class if you would like to learn how to fly.

FUNDRAISING

At Corona Stars cheer, we strive to make our program as affordable as possible. Our main method of obtaining this goal is offering fundraising opportunities. <u>All fundraisers require a Fundraising Approval Form</u>. This form is available at the front desk and website. The CSC gym will host one or two <u>mandatory</u> fundraisers a season. All athletes will be required to participate.

PRACTICES

There is a viewing area designated for all parents/friends. Parents/friends are asked to stay in that designated area and not come into the gym. We want your child to get the most of every practice. In order for this to happen, we need their full attention. Therefore distractions must be minimized at all costs.

Coaches/Director reserves the right to close practices or the gym at any time.

Practice schedules can change. If we feel the team needs more practice to ensure their readiness, we may call an extra practice. We will add practices before competitions. We will inform you as soon as possible about such changes.

Your opinion regarding practice and routine construction does not count. The staff makes all of the decisions. Athlete's may be moved from one position to another, or one team to another at the discretion of the coaches.

CSC coaches reserve the right to cancel practice or competitions when excessive absences by any athlete(s) of the team negatively impact team practices and/ or performances. Paid fees for cancelled practices and or competitions will not be refunded for any reason. I understand that if my child gets injured, they are required to attend all regular team practices to observe those practices.

TRANSPORTATION/TRAVEL

All transportation/accommodations to competitions, practices, and other events are the sole responsibility of each family. We will make every effort to provide information in a timely manner. However, if a competition/practice is cancelled or rescheduled, CSC will not be responsible for reimbursement for any reason. Make arrangements for your child to participate in the entire competition if you, (parent) are unable to stay for the entire competition. During the competition season, cheerleaders will be asked to travel. Some athletes will travel to national events out of the state. All team members are required to wear their warm-ups or CSC all-star clothing to each function. All team members will stay together with the coaches and follow travel regulations.

UNIFORMS/ATTIRE

Please keep all CSC clothing, Warm-Ups and Uniform in good condition. Please report any lost/damaged uniform items to the front desk. The cost of replacement will be responsibility of the athlete.

In compliance with uniform lines, all undergarments should not be visible. Options include; clear bra straps, adhesive, etc. If standards are not met, athletes will not be permitted to move forward with call time procedures.

Although we appreciate your Corona Stars Cheer pride, you CANNOT create and/or sell your own CSC clothing or accessories of any kind. That includes anything showcasing the CSC Logo/name.

Corona Stars Cheer retains the rights to place its athletes on the team it feels will best suit them and the program. If an athlete has the option and decides to cross over (be on multiple teams), perform a solo, duet, or trio, they must be willing and able to learn all material by deadlines for both teams and fulfill all responsibilities required by each team. All cross over athletes are responsible for any additional comp fees, private, and / or items that are needed for teams they are on. The athlete may purchase a second uniform from our office.

Practice attire and guidelines are mandatory. If the athlete(s) are not in appropriate attire, the Coaches have the right to not allow them into practice due to safety.

No jewelry, etc. (We ask that athletes do not bring jewelry to practice) This means no necklaces, bracelets, rings, etc. All earrings, nose rings, tongue rings, any face piercings, belly button rings need to be removed. It is preferred that all piercings are removed to due safety concerns. No tattoos or inappropriately dyed hair styles should be visible when wearing Corona Stars Cheer apparel.

Practice attire includes; appropriate cheer shoes, hair securely pulled back away from the face in a high ponytail or bun to ensure safety during stunting and tumbling, and appropriate specified practice wear.

At no time will CSC allow artificial nails. If the athlete has artificial nails they will not be allowed to practice until removed. Athlete will risk being pulled from competition due to missed practices. Artificial nails are safety issues and no exceptions will be made. Additionally, all nails must be kept shorter than finger tip.

I acknowledge that if my child shows up to a scheduled practice without the appropriate practice attire, I will be charged, to provide your child with the appropriate practice attire on that day.

Outside shoes must be removed in stretching area and placed inside gym bag.

Only specific cheer shoes are allowed on flexi roll mats / spring floor. It is important to have proper shoes for stunting and tumbling.

COMMUNICATIONS

We are open to discussing the progress of your athlete at appropriate and applicable times. Please feel free to ask athlete specific questions; coaches are happy to clarify anything that causes question or concern by email.

We are committed to the success of your athlete at CSC and will continue to give the best customer service to our CSC Clients.

Please refrain from texting or calling the staff outside of gym-time. We appreciate the commitment of our coaches and staff but want to be sure they also have their own personal time as well.

ACKNOWLEDGE AND AGREEMENT FORM

Commitment, Attendance, & Code of Conduct

__1. The All Star Cheer season is a <u>FULL YEAR COMMITMENT from June 2018 through May 2019.</u>

2. Your child will be suspended from class and charged \$25 for displaying inappropriate behavior, not following the code of conduct, or refusal to follow gym rules and coaches' instruction. You are still responsible for your child's monthly fees and account during the suspension period, and a \$25 fee will be charged for each missed practice. All fees must be paid prior to returning to practices once the suspension is over. Additionally, we also reserve the right to replace or remove a cheerleader from any or all programs if they, or their family, are detrimental to Corona Stars Cheer.

3. For the best interest of the athletes and teams, we reserve the right to move a cheerleader from one team to another at any time throughout the competition season. If the athlete drastically improves on skills, or is not able to keep up with teammates, a movement could occur. We want every-one to have a happy and positive experience!

4. It is <u>mandatory that all Team Members are to attend their team's practice</u>. I understand that if my child gets injured, they are required to attend all regular team practices to observe those practices. If they are sick and injured and are unable to participate in practice, it is important that the office staff is notified by the parent prior to the sick day / practice. A 3 hour notification must be given prior to the practice, or it will be considered an unexcused absence and charged a \$25.00 fee. If they are contagious and provide a doctor's note, they will be excused. Additionally, if you miss summer practices or have late enrollment, your athlete's spot on a team is not guaranteed! They could remain as an alternate until a spot on a team becomes available. I acknowledge that if my child misses a practice two weeks prior to a competition, a \$100 fee will be charged to my account.

5. I understand that if my child misses practice for more than 29 days, or decides to quit Corona Stars Competition program, at any time, from the acceptance dates to the end of the competition season, I will be charged a \$500.00 CANCELATION FEE. If sent to collections, you are responsible for their fees & the drop fees. A drop form must be filled out in person, and is only available at the Corona Stars office.

6. If at any time your child misses a competition of an unexcused reason, they may lose their spot, or removed from the next competition. CSC staff reserves the right to make this decision. Also, if you decide not to attend a competition at any point during the season, you will be charged a \$200.00 fee for missing the comp. All comps charge for athlete changes.

7. If your child will be out for any practice during the summer months only, please fill out a vacation form and turn it in to the front desk. All team members must hand in their summer vacation request forms 3 weeks into summer. If a notice is not handed in, that child may lose their competition spot and will sit out a practice for a day. All vacation slips, for the entire season, must be turned in prior to August 1st, 2018. After, August 1st 2018, a participant will only be excused for graded school activities or severe illness with a doctor's note. If you are requesting an excuse for a school activity, you must provide a flyer from the school along with the teachers signature, 2 weeks prior to the event, or the \$25.00 fee applies.

8. If a participant quits during a season, your uniform bearing our logo is due, back at the gym within 24 hours.

9. The sign contract is valid regardless of team changes, placement, or gym location. Additionally, once committed to a competition season, you agree to NOT use, or train, at any other gym during that season.

Registration & Fees

____10. Registration fees are due annually from the date of your registration, and all cheer fees & competition fees are non refundable.

_____11. Monthly fees are due on the 1st. If not paid, a late fee of \$25.00 is automatically accessed. All CSC members are required to pay their monthly fees electronic draft. If it falls on a weekend or holiday, it will be taken out on the Friday before.

12. All monthly tuition payments must be paid via electronic draft. A \$25.00 fee will be incurred for payments returned for insufficient funds. I acknowledge that if my account is still not current after 7 days, my account will be placed on hold. Additionally, a Credit Card must be placed on file; if your athlete misses practice, the card on file will be charged.

13. If monthly payments and assessments are declined, there will be a \$25.00 Service Charge that must be received within 5 days. Corona Stars Cheer reserves the right to forward the issue of non-payment items to the Riverside County District Attorney Restitution Program and your child might be dismissed from the program.

14. Your child's monthly fees are due regardless of how many classes your child attends and/ or holidays that Corona Stars observes in any given month. Our class fees are based on a 4 week month, while some months have 3 weeks and other months have 5 weeks.

___15. All monthly fees, assessment fees, and/ or uniform fees must be paid in advance of an event in order to participate.

16. If you choose to pay your fees in full, and choose to discontinue anytime from June 2018 through May 2019 your paid fees are nonrefundable. The \$500 All Star drop fee will be deducted and the remaining balance will be kept in your child's account for any future CSC use (Such as - Competition drop fees & changes, coach expenses, uniforms, and crossovers). REFUNDS will not be given. <u>All fees are 100% non-refundable for any</u> <u>reason</u>. Any attempt to do a chargeback on the account or cancel a check, we will report it to the district attorneys office, and you will be responsible for all court filing fees, collection charges, and work travel time.

17. National fees / Special Qualifier / Championship Fees / Out of State Comps / Summit / Summit Packages are not included in the Competition Fees. Once we qualify, a fee will be determined off of their pricing.

_____18. Your account must be current for your child to participate in team practices, tumbling classes, open gym, private lessons, and / or compete at competitions.

__19. Solo fees, Duet Fees, Trio Fees, Crossover Fees, Specialty Teams and Private Lesson Fees must be paid by the parent. All fees TBD.

20. When entering mid-season, we will break down the additional fees into monthly payments that will be due on the 15th of each month. The payments for additional fees are separate from the regular monthly tuition that is due on the 1st of each month. You will be charged a <u>\$200 payment</u>, on the 15th of each month, until the additional fees balance is up to date.

_____20. Every participant must purchase and wear the properly designated cheer shoes while in the gym. They are not to be worn outside the gym at any time. This is to ensure that our floors remain in the best condition.

21. I release CSC the right to take pictures or video the progress of my child. Parents & athletes are unable to video tape in the waiting room or gym. If you would like to video your child, arrangements can be made at the owner's discretion.

22. If you choose to participate in private lessons, your instructor reserves the right to set up a personal contract with you and your child. All private lessons must sign in and pay the front desk, in CASH, prior to each and every lesson. A Credit Card must be on file to hold your spot for a scheduled private lesson. If you cancel / fail to show for your scheduled private, your card will be charged for the spot that was held for you.

_23. Additional clinics, choreography sessions, camps, etc. will be \$20 to \$40 per session, per athlete.
