RIVENHALL PARISH COUNCIL MINUTES OF THE COUNCIL MEETING HELD 3RD DECEMBER 2013.

Present: Cllrs. Abbott, Bills, Wright, Prime, Brailey, Clark and Turner.

Also present: Parish Clerk and 1 member of the public.

833.. To receive apologies for absence.

There were no apologies received.

834.. Disclosure of Pecuniary Interests relating to matters on the Agenda.

Cllr. Abbott disclosed a non-pecuniary interest in all items related to ECC.

835.. To approve and sign the Minutes of the meeting held on 5th November 2013. The minutes, after being amended at item 824(x), were unanimously approved and then signed by the Chairman.

836.. Public Forum for 10 minutes.

The following matters were brought to the attention of members:

Damage to 30mph sign along Church Road - this has been reported to ECC.

837. Matters for Discussion.

i. <u>Long term car parking obstructions in Foxmead.</u>

This is an Essex Police matter if vehicles are obstructing the footway. The problem is to be monitored and, if necessary, added to any future submission for parking restrictions to the NEPP.

- ii. <u>County Highway maintenance.</u>
 - (a) Church Road zebra crossing has been repainted but not reinstated
 - (b) Other repairs have been given a completion date of January 2014.
 - (c) Mud and stones deposited along roads could be from farm or contractor's vehicles; UK Power Network have cleaned Church Road as a goodwill gesture.
 - (d) UK Power Network indicate that the footpath crossing Rickstones Road will be reinstated in due course.
 - (e) Rickstones Road will be closed for 2-3 days during January 2014, the exact dates are not yet known.
 - (f) Rickstones Road drains below Stoverns Hall Farm are blocked and have been reported to ECC..
 - (g) Posts and streetlight were damaged near Hoo Hall Farm drive on 23rd
 December 2013. The Council's maintenance contractor will check to see if the dog bin has been damaged.
 - (h) A bollard at the junction of Oak and Henry Dixon Roads has been damaged and will be reported to ECC.
 - (b) Motts Lane Bridleway will be closed from 16th December 2013 for up to 6 months for the installation of the new pedestrian footbridge.

iii. <u>General maintenance:</u>

- (a) Tree planting (Woodland Trust trees).

 The trees have been heeled in pro-tem by Cllr. Clark.

 Some will be used for hedging along oak Road from the Railway Bridge along to the field gate entrance and some will go to the Church for their planting scheme. The Chairman will ask if the School have any tree requirements.
- (b) Maintenance Contractor.

The maintenance contractor will check out the rubbish accumulated at the garages off Tusser Close and report back to Cllr. Bills for possible referral to either BDC or Greenfields for clearance.

iv. <u>Purchase of 2 trees to replace those lost in Foxmead and 1 in remembrance of Dennis Gibbon.</u>

Proposed by Cllr. Abbott, seconded by Cllr. Wright and unanimously agreed that two trees be purchased for planting at Foxmead at an estimated cost of £40.00 per tree and that one tree grown from Mr. Gibbon's own stock be used as a memorial tree.

- (d) Average speed cameras along the A12 has highlighted the debate regarding improvements to the A12 junction with Oak Road and the various road signs in the vicinity. The HA indicate that there will be no improvements at The Fox junction until 2015/16 at the earliest.
