- 1) Fill out this entire application LEGIBLY and be sure to sign and date the application. If you do not sign the application, we cannot complete your background check. This will delay your application process.
- 2) Please bring two forms of current identification (picture ID and social security card preferred) and two months of your most recent check stubs or any other source of income. If you do not include this information, it will delay your application process.
- 3) Be sure to sign and date at the employment and tenant verification forms. **Do not fill out anything in the middle of these forms.** We will send these forms to your employer and your previous landlord, THEY will fill them out and return them to us.
- 4) All checks or money orders are to be made payable to Audubon Park Place Apartments. The non-refundable application fee is \$75.00 **for each adult** that will be staying in the apartment and the deposit is \$500.00 and **must be made separately** from the application fee(s).
- 5) **We can only accept money orders for the application fee and the security deposit. We no longer accept personal checks or starter checks. We do not accept cash.**
- 6) The deposit of \$500.00 must be received in full before we can hold the apartment for you. The application fee will **not** hold an apartment.
- 7) Once the deposit is received, you have 30 days to move into the apartment. After 30 days, the security deposit is non-refundable.
- 8) The application process can take 2-5 business days from the time all the information has been returned. Make sure everything is turned in so we can start your application process.
- 9) The \$75.00 application fee is non-refundable and will be deposited immediately. If you are not approved, the \$500.00 will be returned to you.
