Executive Summary

Littlefield Consulting was retained to conduct a public opinion survey of likely voters in Monterey, CA. The survey was put into the field on Wednesday, June 25, 2014. The survey was completed on Thursday, June 26, 2014.

866 voters answered Q1, and 446 voters answered Q10 - the last question. N = 457 is based on the number of voters that answered Q09. The margin of error (MOE) is based on a Monterey County eligible voter population of 164,032 registered voters and N = 457 The MOE is +/-4.58 and the confidence level is 95%.

The survey highlights include the following:

- Only 33% of respondents think the County is on the right track
- 73% of respondents think vacation rentals are important to the local economy
- 68% of respondents think vacation rentals should be legal in Monterey County

There was an oversampling of women and older voters. Once weighted, the results on the final question about regulating vacation rentals were:

Other people say a highly restrictive ordinance would cause short-term rentals to close or to move underground and away from County regulators and result in a loss of tax payments and tourism dollars.
