Every jurisdiction in the conference is sovereign, and Florida will maintain the non-recognition of the Louisiana Jurisdiction. I did receive letters from the National heads of Holy Royal Arch Masons and Royal and Select Mason affirming that those bodies would not allow Louisiana to be a part of their conference. Therefore, those bodies are at liberty to attend the meeting. Nothing to date has crossed my desk concerning Knights Templar, consequently the Florida delegation will not be able to attend.
