## State News Updates

June 10, 2020

- **Governor Cuomo held a press conference at 11:30 AM and announced the following:**
  - Total hospitalizations at 2,190 on June 9.
  - Total deaths increased by 56 on June 9.
  - Reopening:
    - New York City is the only region in the State that has not entered Phase Two.
    - The numbers that are important now are daily testing results.

    - Need to stay disciplined as other states are showing increases as they reopen.
    - The Governor believes the State must do two things simultaneously:
      - Monitor the reopening.
      - Energize the reopening.
        - Simulate the economy with large scale development projects.
        - Capitalize on the moment of reduced activity.
          - Fast-tracking the construction of a new LaGuardia Airport.
          - Accelerating \$2 billion in MTA projects.
          - Rebuild Belmont (including new arena for the New York Islanders).

- **Governor Cuomo issued Executive Order 202.40. Highlights include:**
  - Reducing the frequency of tests required for personnel at nursing homes and adult care facilities in Phase Two regions to once per week.
  - Mandating that, in the event a school budget is not approved by the voters, any resubmission to the voters of the original or revised budget shall be conducted at a date and by a process determined by a future Executive Order (but not before July 9).
