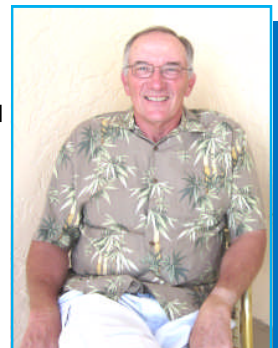
Meet Your New Board Member ~ Rich Bielawiec

On March 5th, the planting of new Pygmy palms, Ixora plants and a Foxtail Palm around the swimming pool, along with new curbing was completed. It looks great! Did You Know?

1. If you rent your condo, you must pay the \$15 Renter's Fee to the Condo Association prior to the arrival of your renter. If not received from the owner, the Condo Association will ask for the fee from the renter upon their arrival, so don't be embarrassed!
2. Please be sure to inform your renter that trucks, motorcycles, boats and non-owner dogs are not permitted.
3. According to the 2010 Lakeside Directory, owners come from 16 states and 2 foreign countries (Canada and Germany) with the greatest number of owners being Florida residents (30) followed by Massachusetts (22) and New York (16).

Happenings at Lakeside



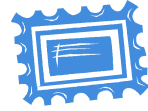

Al or Ally Gator

Have you seen our resident alligator cruising around the lake recently? He/she seems to have the lake to him/herself. Shyness does not appear to be a problem with this dude/dudet. On a recent day your editor saw our friend cruising along the bank, at dusk, checking me out, and it almost seemed as if he/she was looking for a photo op, so I obliged. It is unknown whether or not this alligator comes out of the lake to sunbathe, but most likely does, somewhere. The length is open to speculation, but would appear to be about 4+ feet.

Here are a few facts about our reptilian friend (sources: Univ. of Florida & Smithsonian Natl. Zoo):

1. In 1987 the Florida legislature designated the American alligator (*Alligator mississippiensis*) as the official symbol of the state.
2. The family Alligatoridae first appeared on earth about 35 million years ago.
3. The Spaniards, during their exploration of Florida, called the reptile "el lagarto", meaning, "the lizard".
4. The University of Florida sports teams use the alligator head as their logo and are called "Gators".
5. Normally, alligators avoid humans, but alligators that have been fed by humans will move toward humans (at 7 mph) and can become aggressive. In Florida, it is illegal to feed alligators.
6. Alligators hunt primarily at dusk or during the night. Diet depends on what is available to it, which means that it will eat just about anything, including small dogs and cats, so beware!
