WHEREAS the Parties hereto jointly provide firefighting services to the respective Town and Rural Municipality above mentioned, and wish to set forth their respective responsibilities pertaining thereto.

- 1. The Party of the First Part shall be responsible for:
 - a. Supplying, maintaining and managing the necessary building to house the firefighting equipment and vehicles.
 - b. Recruiting and training all volunteer fire fighters.
 - c. Keeping in force all necessary insurance respecting the fire fighters
 - d. Any billing for fire calls in the Town of Alameda not paid for by November 15 h in each year shall be turned over to the party of the First Part.

- 2. The Party of the Second Part shall be responsible for:
 - a. The supply and cost of all firefighting equipment and vehicles, with prior approval of Council.
 - b. billing all persons receiving firefighting services.
 - c. Maintaining all firefighting equipment and vehicles in proper working order, and to pay any costs incurred in such maintenance.
- 3. This Agreement shall ensure to the benefit of and be binding upon the Parties hereto, and their respective successors.
