

IRPC March 5, 2020 Meeting Minutes

Officers and Member Attendance: President Don E called the meeting to order at 7:00 p.m. with all Officers present.

December Meeting Minutes: Motion to Approve December Meeting Minutes as written - 1st Pete A., 2nd Bob R., motion approved.

Treasurer Report: Rick C Beginning balance \$17,107.20. Ending balance \$13018.60. Detailed report of all monies spent and received from memberships and donations. Motion to Approve Treasurer Report – 1st Dale., 2nd Bob, motion approved.

Range reports:

- **Summation:** Most ranges need some maintenance but will be addressed as weather permits. Trap/Skeet committee will be reinstalling the trap machine in preparation for the High School Trap team to begin their season. Bob still needs to do a little more work with the machine to get an idea of cost to fix and whether it can be fixed. He will update next meeting.
