BROOKLINE HOME RECEIVES NATIONAL AWARD





An historic home in Brookline, MA, has received the Platinum award as the best remodeling project in its category of Remodeling, Entire Home over \$250,001 per unit as part of the 2011 Best in American Living Awards (BALA) by the National Association of Home Builders (NAHB). The architect-designer for the project was O'Sullivan Architects in Reading, MA; the remodeler, interior merchandiser, and developer was Brookline Development Corp. of

Chestnut Hill, MA; and the land planner was VTP Associates Inc. of Newton, MA.

The Victorian-era residence, on 63 Harvard Ave., had been split into three living units and was in complete disrepair. The builder worked with the city preservation groups and planning departments to restore the property and preserve the elaborate characteristics of the original structure and replaced the back of the main house with two new, larger units and private garages. Two carriage houses were also restored to their original beauty and turned into detached living units. Extensive landscaping ties the three buildings together. 
MCNEILL WINS ZONING APPEAL



NEBA member Julie McNeill won a zoning appeal at the Massachusetts Supreme Judicial Court (SJC). Her client had gone before the Shirley Zoning Board of Appeals for a special permit to expand his pre-existing nonconforming use and he was denied. McNeill appealed that decision to Land Court

and after trial, the court found for her client. The town appealed that, and the MA Appeals Court found that the town's concerns about density justified the denial. The SJC then granted Julie's application for further appellate review and, after the hearing, overturned the ruling of the Appeals Court and affirmed the Land Court decision.
