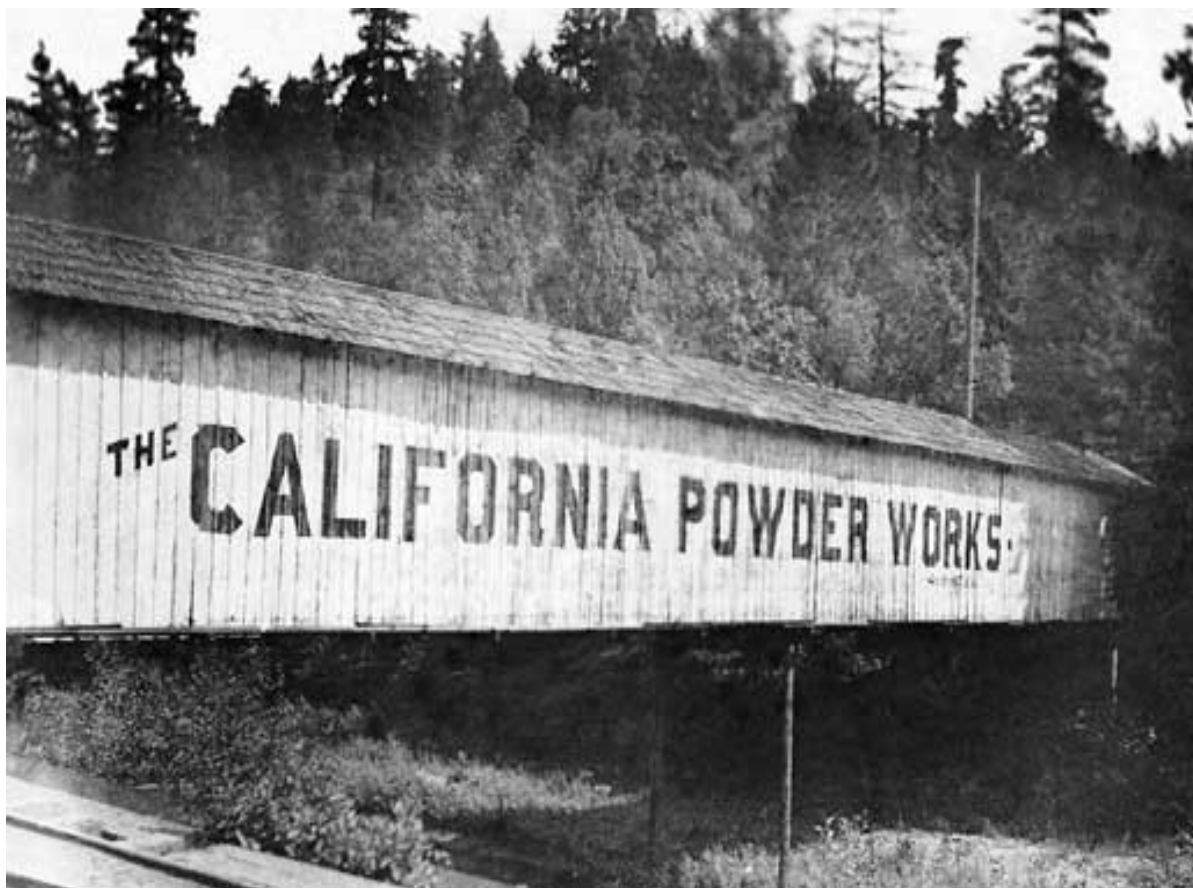

PRESIDENT'S MESSAGE

Dear Members of Paradise Park Masonic Club (PPMC):

We are now working on preparing the annual TADS billings. The format will be a bit different this year in order to facilitate use of our accounting software's functions related to Accounts Receivable management.

Historically, the TADS billing has been billed on a single invoice in October. Members have had the option of paying the full amount or paying half now and half in the spring. This year, each member will receive two invoices, each representing one-half of the annual billing. One invoice will be dated October 1, 2019 with a due date of October 31, 2019. The other invoice will be dated March 1, 2020 with a due date of March 31, 2020. As in the past, Members will have the option of paying the whole amount (both invoices) or paying the October invoice by its due date and the March invoice when it becomes due this spring. This billing process will allow the accounting software to properly age the invoices and allow the Board to utilize the Accounts Receivable management capabilities built into the software. We will include an explanation with the billings when we mail them out.

The Board is continuing to work on various processes and procedures with an eye towards streamlining operations and reducing operating expenses.

Board of Directors OPEN Session Minutes

August 17, 2019

9:45 a.m. – SOCIAL HALL

1.0 OPENING ITEMS

- a) Roll Call: 4 Board Members present, with resigning Board Member Bruce Wildenradt absent. 34 Members signed in.
- b) The Invocation was given by Mark Gienger. The Pledge of Allegiance by Mark Gienger and all in Attendance.
- c) Consideration of Late Additions to the Agenda: Firewise Information/ Report and Fire Policy discussion.
- d) Reports from Executive Meeting – Mark Gienger. July 20th, 2019 minutes read.
- e) Open minute copies from June 15th July 8th 2019 and July 20th 2019 Executive Minutes were given to all in attendance. Approval to follow at the end of the meeting after Member input or corrections.

2.0 DIRECTOR REPORTS

- a) Manager: Steve reminding all about the PPMC Rule regarding boats, trailers etc. Rule allows for these types of items to be on Member allotments for maximum of 24 hours and allowed to be parked in the PPMC firehouse parking lot for up to 72 hours.

Steve reporting the he and his crew will be working around the Park to remove redwood suckers. Please help in this area if you also have suckers on your allotment that need removal. Steve praising the Staking Committee for their hard work. He has given them 15+ staking request and they are getting all caught up. Steve and office appreciative of the Committee's efforts.

Steve informing all that there will be no more picking up of mail/packages by Members, for other Members. Meaning, only those that have a key can access the mailboxes. If you are known to pick up mail for other members, you must now have their key. Too often mail is not getting to members.

Steve addressing the Membership to put to rest more rumors running throughout the Park regarding his off hours and part time job. Steve ensuring all that he is always available. In the event of an emergency, he can leave his part time, evening job, immediately to answer emergency situations.

Steve asking all Members to please stop painting the streets in the Park. Members taking it on themselves to mark streets. Please stop.

Steve telling all that he and his family will, once again, be hosting Bingo. Bingo will be held the 3rd Saturday of the month beginning in October of this year. Any additional funds received from Bingo will go to the re-funding of Bingo. The month of September, Bingo will be held on Sunday night September 1st with doors opening at 6:30 and games to begin at 7:00 pm. All encouraged to attend!

- b) President: Joe Mayo reporting that his report today is like message he wrote for the latest bulletin. Encouraged by the new Board and believes all are there to work for the good of Paradise Park.

Joe reporting that he has had a chance to begin looking at the financial situation here in PPMC and is concerned about it. He believes in the next 6-8 weeks there will be a cash flow problem that will need to be handled. Joe is looking at controls for the future. President Joe making clear that money is not being spent in a wasteful manner, just that not enough funds are coming in and expenses are high. He plans on spending the bulk of his time with the Park Bookkeeper and CFO to address situation. Joe also reporting that he plans on having quarterly financial presentations for Park Members to answer any and all financial questions. Goal is to report to Membership about finances and objectives. Will be in a "Town Hall" format.

- c) CFO/Treasurer: CFO Verdie Polizzi also reporting on working with Joe and the Park Bookkeeper to be on the same page as far as PPMC financials. With the non-passage of the assessment increase it will become necessary for services to be reduced. More information to follow on which services will be affected.

CFO Verdie reporting that the office has received a Membership application and offer for the property at 239 Temple Lane. Information to follow. Verdie reporting that multiple lawsuits have been closed in the last 6 months, which will help with Park legal fees.

The Annual Audit is almost complete and the draft has been received. A few items remain but should be completed by the August 31st deadline. Verdie hoping that next year's audit will be less costly as many accounting items have been cleaned up and corrected.

Open Minutes (Cont.)

Board Vacancy Discussion (Moved from New Business 5.0 a)

a) President Joe explaining to all in attendance how the replacement process will be handled per the PPMC bylaws. Board Member Bruce Wildenradt has resigned, and a replacement is to be chosen from a list of past Board Members from the last five years. Joe has contacted these members prior to the meeting to find out if they are able and willing to take the temporary position. The 10 names will be randomly drawn from a hat, and it will be confirmed by office Secretary if they have a willingness to accept the position. Each time a name is drawn, the Board will vote. Once a name has been drawn, willingness confirmed and a unanimous vote received, the replacement Board member will be chosen.

At this point President Joe picked several names from the hat, until former Board Member Kurt Likin's name was drawn, willingness confirmed, and a unanimous vote counted. Joe making a motion to accept Kurt Likins as the Vice President of the Board. Second by Mark Gienger. Passed 4-0. Kurt Likins will be the Vice President of the Board until the next Board election in spring of 2020.

b) Budget - Will be working on cyclical budgets to provide more real time data to membership. No meeting has taken place yet.

e) Long Range Planning - Committee has not met yet. Liaison Joe Mayo reporting that he will be back in the Park for over a week in early September and hopes to schedule the first meeting at that time.

f) Recreation - Committee has met twice. Chairman Tami MacDonald is working on the Labor Day dinner reservations. Committee working on calendar for this year looking at having movie nights and/or game nights. Tami reminding all that volunteers are always needed!

g) Staking - Bear Butcher reporting that 8 stakings have been completed this month. 5 new stakings were received as well as 2 verifications. Committee is working very hard to get caught up.

h) Tree - Donna Sorenson reporting that one request was received. Committee thankful to Steve for keeping up with the Tree log and process.

4.0 TEAM REPORTS

a) ERT - Lead Dick Lovelace is out of town but submitted a written report to membership, read by Winston Chavoor: The PPMC ERT has been meeting regularly. The fire team is getting organized and trained under Andrew Almanza, Fire Team Lead. The Traffic Management Team is getting organized, and map books are being assembled for all ERT Team members, under the direction of Winston Chavoor, Traffic Management Team Lead. An inventory of first aid and medical supplies has been conducted under Jean Cook, Medical Team Lead. A visual inspection of most PPMC allotments has been conducted by the Visual Inspection Program (VIP) Team. They have identified those without sufficient house identification numbers, hoses for fire suppression and chimney screens. That information will be presented to the Board for recommendations. The following are priority issues which the ERT Team requests be addressed with priority:

1. The emergency siren at the front gate is still not functioning. It has been in this state for many months.
2. Two of the Automatic Electronic Defibrillators (AEDs) are no longer functional and need to be replaced. They are currently in the manager's office.
3. Three of the oxygen tanks are depleted and need to be refilled. They are currently in the manager's office.
4. One of the five medical go bags has become unusable. The backpack was completely worn out, the zippers corroded, and all of the medical supplies inside were depleted or moved to other bags to complete them. A new bag and a complete set of supplies needs to be procured.

b) Orientation - No Report. Liaison Clara Johnston to set first committee meeting soon.

d) Covered Bridge - No Report. Pat McDonald - only Member to sign up for Committee

e) Firewise Information - Submitted to BOD by chair, Betsy Steifelmaier, Sharon Simas & Leigh Wunce. Report read by Betsy Stiefelmaier as follows: The National Firewise Communities Program offers a series of practical steps (landscaping, home construction and design, community planning, etc.) that individuals and communities can take to reduce their vulnerability to wildfire. The program teaches people how to adapt to living with wildfire and encourages neighbors to work together and take action to prevent losses. There are over 1,500 recognized Firewise groups across the nation. Our local Fire Safe Santa Cruz Council, FSSCC is currently in the process of hiring a Firewise coordinator for support for the groups that have been formed or are in the process, as we are. There is no financial cost to participate in the National Firewise Communities Program. However, our community would gain valuable support with our involvement in this organization. What Firewise will do for Paradise Park: Enables PPMC members to support continuation of homeowner/fire insurance. Addresses home wildfire risk in wildland/urban interface. Local community-based solutions for wildfire safety for homes. Gives plan and actions to increase homes' chances of surviving wildfire. 6 Steps for Firewise Recognition: We have formed a committee to develop PPMC risk-reduction priorities. Complete written wildfire risk assessment with assigned fire official. Create action plan – prioritized list of risk reduction projects. Conduct educational outreach event annually. Do wildfire risk reduction investment with 391 volunteer hours. Submit completed application online, when all criteria met. Firewise Goals: 4" reflective, contrasting color, address numbers visible from the street on all homes. Ocean Street Extension egress for evacuation – repair. List of infirmed/disabled for evacuation. Disaster/fire preparation by all PPMC members. County Fire Chief, Paul Horvat, president of FSSCC told us at the August Council meeting that "too many trees, hard to navigate roads and invisible house numbers creates a great hazard for Paradise Park". Betsy asking the Board to mandate 4" reflective numbers on all allotments. Board President Joe Mayo responding that the Board will look at and research.

a) Board Vacancy -**Discussed and handled earlier in the meeting**

b) Office Hours Discussion: Due to financial situation there is a need for cutbacks. Hours of Office operation to be reduced. Specific information to follow the Labor Day weekend.

d) Bulletin Printing- Discussion regarding the printing of the monthly bulletin and the high costs. Board to look at charging those Members that will not receive it electronically, and need the hard copy sent. Board to come up with the cost and report back at the September meeting.

Question regarding the Club Financial situation - President Joe May explaining the fiscal years and income statements. Currently PPMC has a 710K budget- Not enough. He again reminded all that there will be quarterly financial reports in a Town Hall meeting format to answer any and all questions.

Member Diane Seaborn Brown asking about the water bill issues and the possibility of water meters throughout the Park. Believes this issue needs to be looked at again. Water costs continue to rise with no end in sight. Member Mark Zevanove reminding all that the City of Santa Cruz is not fully aware that not all the Members are full time. Need to exercise caution as it might be in our favor. Regarding water costs.

Member Elizabeth Arzouni requesting that the P & L reports be included in the monthly bulletin. President Joe reminding again about the quarterly future reports.

Member John Mancini believes all major costs are in Insurance, Legal and accounting areas. Board Member Verdie emphasizing that the costs of living/operating continue to go up with no increases in assessment or dues.

Labor Day Dance to begin at 7:00 and end at 10:00 per City ordinances.

Member Bob Morgan Reporting on the Ocean Street Extension. Bob encouraging a new Committee to be formed, rather than only him. Board to discuss and have a more formalized process regarding OSE. Kurt Likins now in favor of an Ad-Hoc committee. Verdie reminding all that Santa Cruz County will not pay. They may help with permits and paperwork but will not pay for OSE repairs.

Corrections noted, changed and then approved. Motion to approve with corrections by Verdie. Second by Joe. Approved 4-0.

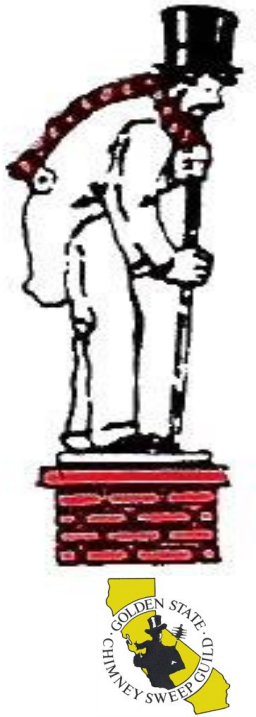
