Resolution 2017-17 Approving Intergovernmental Cooperation Contract with IMLRMA

Resolution 2017- 18 Approving a Contribution of \$1000 to Campton Township for the "Establishment of a Ground-watering Monitoring Network in Campton Township in Kane County" Continuing Research Program.

Motion by Chris Vaughn, seconded by Tim Dell to approve Resolution 2017-18. Brief discussion by the President regarding this study and past studies for well water monitoring within the Township. Residential wells may be targeted for their location in relation to shallow/deep wells in proximity to their own. Residents may voluntarily participate in the study for a fee. Resolution 2017-19 Accepting the Proposal of Quick Cut Lawn Service for the Maintenance for the Village Hall Berm for \$750

Clerk asked current lawn maintenance contractor to provide this bid to kill weeds then apply existing mulch piles to the berm. *Roll Call vote, motion passed unanimously.*

Resolution 2017-20 Accepting Proposal of Corrective Asphalt Materials in the amount of \$29,230 for Road Maintenance

Motion by Pam Conn, seconded by Tim Dell to approve Resolution 2017-20. CAM to apply a sealant product over the newly paved roads within the Village. *Roll Call vote, motion passed unanimously.*

Resolution 2017-21 Accepting the Proposal of AC Pavement Maintenance in the Amount of \$68,229.68 for I.C. Trail and Hanson Rd. Maintenance.

Motion by Mary Damisch, seconded by Janet Marlovits to approve Resolution 2017-21. Chip and Seal type of treatment for I.C. Trail, Hanson Rd. and parts of E. Sunset Views Dr. Motion by Janet Marlovits, seconded by Pam Conn to amend the amount to \$75,000.00 reflecting an additional striping charge. *Roll Call vote, motion passed unanimously as amended.*

Resolution 2017-22 Granting License to Mike Wiesbrock to Cut Hay from the Village Owned 5 Acre Field

Motion by Chris Vaughn, seconded by Mary Damisch to approve Resolution 2017-22. Past Resolution granted Mr. Metz the license to cut this field, however there was a standing verbal agreement with Mr. Wiesbrock made in 2014 which was never canceled. Moving forward the Village Board will grant license annually by Resolution to cut the field and will cancel each license in the fall. *Roll Call vote, motion passed five approved, one abstain.*

Approval of Monthly Bills
