## **General Information**

The 2016 Alligator Fishing Club Challenge is a catch and release tournament.

The Challenge will be held over a 2 days and will commence **Friday 28<sup>th</sup> October at 4.00am and with Lines Out at 2pm Saturday 29<sup>th</sup> October 2016**. All score sheets need to be handed into the Jabiru Sports and Social Club no later than **4:00pm Saturday 29<sup>th</sup> October 2016**. Any late or incomplete score cards will not be accepted.

The organisers reserve the right to terminate the participation of any team or individual in their absolute discretion. Should team or individual's participation be terminated they will not be entitled to any refund or other monies.

It is a condition of entry to the AFC Challenge that you participate entirely at your own risk. You must take care for your own safety and that of the other participants, officials and the general public.

**Teams:** must consist of a minimum of 2 and not exceed 4 anglers.

All teams must be able to fish independently without assistance from non-team members.

**Fish & Location:** This competition includes Barramundi, Snapper, Jew Fish & Saratoga. Fishing is allowed within Kakadu National Park from public access boat ramps.

## **Fees and Payment Information:**

The cost of entry per competitor is \$170 for adults and \$80 for children (under16).

The entry fee includes:

- Entry into the challenge
- Dinner on Saturday night.
- Competitor Bag
- Tournament long sleeve fishing shirt, stubby cooler, measuring stick for each boat,
- Live entertainment on the Saturday evening.
