

## IRPC May 7, 2020 Meeting Minutes

**Officers and Member Attendance:** President Don E called the meeting to order at 7:00 p.m. with all Officers present.

**April Meeting Minutes:** Motion to Approve April Meeting Minutes as written - 1<sup>st</sup> Bob R., 2<sup>nd</sup> Jim D., motion approved.

**Treasurer Report:** Rick C. Beginning balance \$13,451.60. Ending balance \$18,102.23. Detailed report of all monies spent including Gun Show income/expenses, new dumpster service billing, computer update, etc. Motion to Approve Treasurer Report – 1<sup>st</sup> Debb O., 2<sup>nd</sup> Chuck W., motion approved.

**Membership:** 2020 Membership = 69, Lifetime = 113 with a total paid to date of 182. Most of 2019 still pending renewal. Will send out email advising members the range is open and reminder to renew membership for 2020.

### **Range reports:**

### Old Business (continued):

- **5 Year Plan Update** – Bill L. provided a quick update on the new areas for Archery (3D) and Practice Trap. The Practice Trap is being moved now and should be up and functional sometime next week. Will also be considering placing a patterning board by the practice trap. The new road to get to the practice trap area has been established and the 3D Archery area will be established to the east of the road. Ralph W. will be working with the 5 Year Plan committee and will bring proposed walk-through plans to the June Meeting. All plans have to be done in a specific order and must be coordinated with the 5 Year Plan Committee.
