Dispatcher –Carrier Agreement

This Agreement is made this _____ day of _____, 20_____, by and between "CTV Dispatching LLC within", hereafter referred to as DISPATCHER, and _____, hereinafter referred to as CARRIER.

WHEREAS, DISPATCHER is a transportation dispatcher handling the necessary paperwork between a SHIPPERS and the CARRIER to secure "CARGO" for said CARRIER.

WHEREAS, CARRIER is a Motor CONTRACT Carrier subject to the jurisdiction of the ICC: NOW, THEREFORE, in consideration of the promises and covenants hereinafter contained it is mutually agreed by and between parties hereto as follows:

OBLIGATIONS OF DISPATCHER

1. DISPATCHER agrees to handle paperwork, phone, fax calls to, from the SHIPPER to tender commodities shipments to CARRIER for transportation in interstate commerce by CARRIER between points and places within the scope of CARRIER'S operating authority and handle all invoicing to the Broker.
2. DISPATCHER bears no financial or legal responsibility in the transaction between the Shipper, Carrier agreement.
3. CTV Dispatching LLC within agrees to perform all invoicing on the carrier's behalf upon the completion of each individual load. A copy will be provided to the broker and to the owner for their records.

OBLIGATIONS OF CARRIER

1. CARRIER agrees to pay DISPATCHER percent **(10%)** of the face value of the contract between the **SHIPPER, CARRIER & BROKER, CARRIER** as stated on the load confirmation sheet. Carrier further agrees to pay CTV Dispatching LLC within (2) Two calendar days after completion of each load. All billing, invoicing and collections of revenue from customers, brokers, shippers, **consignees (CTV Dispatching LLC)**, etc.- are the sole responsibility of the carrier. If revenue for a shipment or shipments is uncollectible. Payments are to be conveniently paid with any Debit or Credit Card via Text or Email Invoice App. Processed by **Courtney Vaughn Invoice Processing.**

2. Cancellation of loads on the behalf of the Carrier **FOR ANY REASON** the Carrier is still **LIABLE** for the **(10%)** of the load to the Dispatcher.

3. CARRIER gives DISPATCHER authority to provide his signature for rate confirmation sheets, invoices, and associated paperwork necessary for securing cargo and billing purposes only. The terms of this agreement shall be perpetual, provided that either party may terminate same by giving 7 calendar days written notice.

4. The amount to be paid by SHIPPER to CARRIER shall be established between parties on a per shipment basis prior to commencement of each individual shipment. A load confirmation including details of shipment and revenue to be paid will be supplied via FAX by SHIPPER to CARRIER. Confirmation will be signed by DISPATCHER and returned via FAX or email to the Shipper.

5. CARRIER shall be liable for loss, damage, or liability occasioned by the transportation of property arranged by DISPATCHER, SHIPPER while in the possession of carrier.

6. CARRIER agrees to hold DISPATCHER, SHIPPER harmless from any liability for personal injury or property damage occurring during operation conducted by CARRIER pursuant to this agreement.

7. CARRIER will be responsible to comply with all applicable state and federal regulations pertaining to the operation of a motor carrier.

8. CARRIER agrees that it will function under terms of this agreement strictly as duly permitted contract carrier.

9. Carrier may also book their own loads, and you only pay us when we make you money on a per load basis. There are no sign-up fees, or monthly fees associated with your account.

10. If revenue for a shipment or shipments is uncollectible "Courtney Vaughn/CTV Dispatching LLC" will be held harmless and no penalty or deduction of fees will be made. The carrier agrees to maintain all proper licenses and permits to conduct business as a motor carrier in the area of intended operation. Additionally, carrier agrees to maintain liability and cargo insurance at the amounts set forth by the home state of the carrier. Courtney Vaughn. will be held harmless in the event of any and all claims. The fee for dispatch services will be 10% of the gross revenue of each shipment with no minimum charge.
