A gentle reminder to all full-time families that I get three paid days off (pro-rated for part-time families). I have never taken all three and always do my best to give you as much warning as possible if it occurs.

I follow the teacher's calendar, so I am open for teacher workdays, strategic planning, etc.

Contact information: Please be sure that you have my cell phone: 703-851-2919 and home phone: 703-323-6788 plugged into your phones. I don't always get reception and sometimes I just don't hear it. Texting is usually best if you need me right away, but otherwise, email is better. Please do not text me between 10pm-5:45am. My phone is my alarm, so texts wake me up...email is better during that time.

Food policy: Please do not bring your own food for children unless we have discussed it. It makes it more time-consuming to serve, other children may want what your child has, and we have some children with food allergies.

Breakfast is at 7:00am. If you will not be here by then, please be sure to feed your child before arriving.

Late pick-ups: Please be sure to be here by

4:00pm. If you will be late, please call me as soon as possible as I or my assistants may have plans immediately following day care. There is a minimum \$15 late fee if you are over 15 minutes late or late twice in one month. I haven't had to be strict about this in the past, but unfortunately, I must this year.



Payment policy: Fees are due the first Monday of the month, unless otherwise discussed. I will invoice you the week prior to the due date. You may either pay by check or credit card (still in the process of activating this).

My temporary absences: I have a few children who need to be walked to school. I also have appointments for myself or my girls. If this happens, I will never leave if I would be over my numbers or feel like it is too much for the other person(s) to handle. I will do my best to let you know when I will be away. One of us will walk Monika to school daily around 8:00am. A neighbor will walk her home, but we may have to on some days. Noelle and Aaron are in the 4-year-old program at St. Matthews, and we will walk them there and back Tuesdays-Fridays.

Landscaping: Please do not allow your children to climb on landscaped rocks or play with the yard decorations. The borders are secure enough to keep mulch/rocks in, but may not be steady enough to use as a balance beam. My children, and others, have also damaged yard decorations and other landscaping.

Labeling: Please remember to label all items that you bring here, including your change of clothes, so it doesn't get mixed up with someone else's items. If you're interested,

<u>Name Bubbles</u> (stickers) are great...they will stay on a bottle through a year of daily dishwashing!

Laundry room: Please do not let children play in the laundry room.

Important

The Fairfax County Board of Zoning, as requested by my neighbor, requires that parents may NOT park in the driveway before 8am. Additionally, the gate should be left open until 8am so it's not constantly slamming. My neighbor's bedroom faces the side of our house and the lights and car doors disrupt their sleep. Keeping things quiet at such an early hour will be greatly appreciated by them, as well as myself to keep my community happy to have a business in a residentially zoned neighborhood.

I will continue to have people come in to read or do other activities with the children. Mondays will be Baked Goods Monday, so children will either make a baked afternoon snack or I will already have one ready for them. Wednesdays will be Wacky Wednesday, so we will do something crazy for lunch, like breakfast for lunch or have a special day, like pajama day.
