First, I would like to thank you all for your support and dedication to the Philadelphia Protection Unit. You all are truly valuable employees and we could not commit to protecting our communities without each of you. As you all know the Coronavirus Disease 2019 (COVID-19) has brought about a lot of changes in the United States. On March 19, 2020, the state of Pennsylvania issued a Stay-at-Home directive, which required all indoor malls, shopping centers, and many businesses that are considered non-essential to be shut down. Also, curfews are being put in place to lessen the spread of the virus. The Philadelphia Protection Unit (PPU) is exempt from this mandate as we are considered an essential business who provides public safety. Nevertheless, we want the guards to be protected and to practice safety first.

Our client, and the public at large, rely on us to keep our communities safe and secure. Therefore, it is critical that you report to work every day. Please understand that you are NOT violating these mandates by reporting to work. If anything changes, you will be notified as soon as possible. If you have any questions regarding these mandates, please contact your direct supervisor.

Our employee's safety and health are vital, we are working to get Personal Protection Equipment (PPEs) which may include gloves, mask, and cleaning supplies. We ask that you don't take home any of the PPEs that we provide to you, as everything is limited. If you have a compromised immune system or a chronic condition you are at a higher risk for contracting the virus and we encourage you to stay home. Also, if you live with children or anyone elderly these individuals are also more susceptible to contracting the virus so be sure to remove your work items prior to going into your home and wash those items separately from other clothes. We understand if you decide not to come to work due to the severity of this disease and all we ask is that you please notify us if you make this decision. Also, please know that we may not be able to hold any positions if you decide you can no longer work your shift. If for any reason you feel like the working conditions are not safe please reach out to your direct supervisor for assistance.
