**RELEASE AND INDEMNITY AGREEMENT**

(Victor Cutino & Ann Cooper), Peaceful Ridge LLC (David & Alisa Shoua), Peaceful Ridge Rescue, Inc.(Victor Cutino & Ann Cooper), Rafael & Maria Oliver Vidaud, Philip & Nathaly Desmarais,, Laura Jones, Jessica Walsh, Kristen Roukas, the officers, Directors, Employees, Agents, Representatives, Volunteers, Volunteer Coordinators where horses are present, and (2) my participation in equine activities, including exercising, grooming, caring for, walking, riding horses, and with the understanding that (a) a horse may be startled by sudden movement, noise or other factors, may shy suddenly, rear, stop short, bite, buck, kick, throw its rider or run with its rider, especially when the horse is ridden in the barn area, or on an exercise track where the activity of people or other horses, distractions or other factors such as occur at a horse facility may exist as such do; (b) other participants in equine activities may act in a negligent manner that may contribute to the injury to the participant or others, such as failing to maintain control of the animal, or not acting within his or her ability; © collisions with other equines or objects may occur; and (d) certain hazards such as surface and subsurface conditions may exist where horses walk or run. I AGREE TO ASSUME THE RISKS incidental to such admission and/or participation, including, but not limited to, those risks set out above, and, on my own behalf and on behalf of my heirs, executors, and administrators, RELEASE and forever discharge the released parties defined below, of and from all liabilities, claims, actions, damages, costs or expenses of any nature, arising out of or in any way connected with my admission to Horse Tales Ranch,, Inc. Peaceful Ridge LLC, Peaceful Ridge Rescue, Inc., Rafael & Maria Oliver Vidaud. And/or participation in equine activities at Horse Tales Ranch, Inc., Peaceful Ridge LLC, Peaceful Ridge Rescue, Inc., Rafael & Maria Oliver Vidaud. I further agree to indemnify and hold each of the released parties harmless against any and all such liabilities, claims, actions, damages, costs or expenses, including but not limited to, attorney's fees and disbursements.
