Chairman's Report 2012/2013.

Rivenhall was the winner for the second year running in its class of the Best Kept Village Competition run by the Rural Community Council of Essex.

Once again this award is a tribute to all the hard work put in by residents, local authorities, housing associations and not least the Parish Council contractor who often does tasks beyond the normal call of duty.

One area that remains less encouraging is the state of the local roads and footways. Some local roads and paths are reasonably well maintained but others seem to stay in a poor state for months. The Parish Council is in regular dialogue with the County Council about them improving this situation and we are also very keen to see the three local highways improvements schemes delivered.

In future years the Parish Council may need to take on more responsibilities as the funding settlement in local government changes. This may include more minor highways related work. In other areas, local schemes to assist the community are already up and running such as the salting in icy weather. We are still keen to restart the Community Speedwatch so if anyone wants to volunteer to help, please get in touch.

Finally, it is good to note that community spirit remains strong in our parish with lots of local organisations active, a village shop, bus service, well used local halls and regular

events held throughout the year. Not all rural parishes have been so fortunate and it is only by continuing to use and support these facilities that we will retain them.

TARECROFT WOOD.

The Parish Council has, over the last year, been considering an option of trying to acquire the freehold of Tarecroft Wood, the ancient woodland off Rickstones Road. This wood is currently owned by Essex County Council, which is able to transfer such assets to the community.

The freehold transfer, if successful, would enable the Parish Council to work with conservation organisations and local people to ensure that the wood is managed sympathetically and sustainably. Freehold transfer costs to the PC are estimated to be in the region of £4 to £5K for legal fees and possible fencing reinstatement estimated at £1930.00 (supply only); £14,000K (supply and erect), both approximate figures subject to final measurement. There may be grants available for future management work.

The Parish Council will have more details available at the APA and would welcome the views of residents, either at the APA or via the Clerk, (contact details on front page) as to whether or not the council should proceed.

PLANNING

The Parish Council responded to 2 major consultations recently. The latest stage of the Braintree District Council Local Development Framework was fairly straightforward and mostly uncontroversial as far as Rivenhall Parish is concerned. Our comments were mainly on matters of detail such as making sure that the local community halls were correctly described and also requesting protection for Little Braxted Lane and Rectory Lane. The next stage will be that BDC will consider responses to the consultation before issuing a further consultation document.

The Essex Minerals Plan was much more challenging. This now proposes a new site at Colemans Farm, with access directly on to Little Braxted Lane and a cluster of extensions and a large new site at Rivenhall Airfield. Our response was very similar to that of Braintree District Council in that we did not oppose 2 of the smaller sites on the airfield as reasonable extensions to the existing quarry, but did strongly object to major new incursions into the countryside and the increased HGV traffic that could affect local roads. In total, around 60% of the new sand and gravel extraction for the whole of Essex to the year 2030 is proposed by ECC to take place in or immediately adjacent to the southern half of Braintree District. The next stage will be a hearing before an Inspector later this year.

On individual applications, there were no new major applications in the last year. We did have significant concerns about the continuing use of a local farmyard as an HGV depot and were pleased to see that BDC refused the latest applications in line with the representations made by the Parish Council and many residents.

All local applications and plans are considered by the Parish Council each month and residents are always welcome to attend to view plans and make comments.

HIGHWAYS.

It has been another difficult year in trying to get ECC Highways to attend to potholes, path defects, local flooding and the three major improvement projects listed for our area.

Whilst some local roads are fairly well maintained, others seem to be left for months and even when contractors are in the parish doing work, they still leave some of the worst maintained areas. Two examples are the poor state of the path under the railway bridge and the very poor state of the road surface and section of paths in Rickstones Road. ECC now say that the former will be fixed by April, so that will be over a year since it was first reported !

The three major schemes on the Highways Panel list for Braintree District are:

7.5 tonne weight restriction to reduce HGVs going down Oak Road to the A12 junction Widened path, safety rail and 'priority working' under the railway bridge Rebuild and kerb verge, rebuild drains and investigate flooding in Rickstones Road

Unfortunately the Highways Agency has given only a possible prospect of improvements to the Fox junction and no prospect of any improvement to the Hotel junction. They state this is due to budget cuts and the fact that, in their view the safety record is acceptable. The Parish Council does not accept that the safety record is acceptable and has continued to correspond and meet with the Agency on the need for the vital work to improve the junctions which was due to have taken place a decade ago. The fact is that residents in Oak Road continue to suffer impacts into their property due to loss of control of vehicles at the A12 junction. The best the Highways Agency say they are likely to be able to do in the short term is improved signage.

BDC PARISH CHANNEL SWEEPING PROGRAMME.

Channel sweeping is scheduled over four dates during 2013/14 as follows: Monday 1st July 2013, Friday 18th October 2013, Wednesday 5th February 2014 and Wednesday 28th May 2014.

The sweeper has a programmed route concentrating on main highways where there are kerbs. If there are any areas that require particular attention, please call BDC Customer Services on 01376 552525 or e-mail *csc@braintree.gov.uk* at least one week in advance of the due visit.

PUBLIC FOOTPATHS.

<u>GENERAL MAINTENANCE AND UPKEEP WITHIN THE</u> <u>PARISH.</u>

During the year the parish Maintenance Contractor, along with the parish Tree Warden and other members of the Parish Council, has been busy making good, fair wear and tear items in and around the Parish.

Once more bulb planting has been carried out, with in excess of 1,200 daffodil bulbs and snowdrops, both at Rivenhall and Rivenhall End. There are still some areas that could be planted in future years, and residents are invited to let the Parish Council know if they have any suggestions. In addition to bulb planting, trees have been planted at both ends of the Parish. One tree in particular, an oak, was planted on the Village Green at Beech Road to commemorate the sixtieth year of the reign of our present Queen. This tree was donated by Braintree District Council. As the season progresses a close watch is being kept on the symptoms of "ash die back" disease, on mature trees and saplings.

Additional flower planters have been installed in Rivenhall and Rivenhall End. The seat originally installed in the former play area in Rivenhall End has been moved to the green next to the Rivenhall End village sign. The play area has been returned to the original owner, due to the lack of use and funding plus a negative report regarding Health and Safety issues.

Ongoing work has been undertaken by the Maintenance Contractor, including grass cutting (a major task in the growing season) and the clearing of footways. Posts have been renewed and painted around the Village Green and the painting of seats and notice boards where necessary. The general aim of the work around the Parish is to keep the facilities in good working order, and thanks must go to those in the Parish who make this possible. In particular, the Maintenance Contractor (Tony Walsh) for his regular litter picking and grass cutting. These activities ensure that the village has a high standard of neatness and tidiness.

The Parish Council intends that such work and standards will continue in the future.

WINTER SALT BAG SCHEME

For the second year in succession, the Parish Council was able to secure a supply of salt & grit from Essex County Council. This year we took the decision to spread the salt on hearing the almost certain forecast of heavy snow & ice in January. This proved to be particularly effective in the centre of the village where the salt and grit prevented the snow from settling and then freezing afterwards.

Our small team of volunteers worked hard to keep the many slopes, pathways, steps and bus stops clear throughout the parish. We were not able to clear all walkways due to the limited supply of salt and manpower. Greenfields Community Housing Association.

Over recent years, Greenfields CHA and the Parish Council have been working together for the general benefit of those who live in and visit the parish. Additionally, Greenfields have financially supported several Parish Council initiatives including the supply of a new Salt bin & contents for the slope at the Tusser Close garages. They also assisted with the location and supply of a new concrete pad when the yellow salt bin was relocated. Again, they provided a grant to supply our team of 'salt & grit' volunteers with snow scoops & high visibility waistcoats. Very recently, they provided financial support to help with the purchase of a modern fold down baby changing unit at the Village Hall for 'Riventots' the play and stay mother and child group. All in all, Greenfields CHA have and are showing great support for the community, so thank you everyone at Greenfields, your help is very much appreciated.
