State News Updates

April 1, 2020

- Governor Cuomo held a press conference at 12:15 PM and provided the following information:
 - o 83,712 have tested positive:
 - 12,226 hospitalized.
 - 3,022 ICU patients.
 - 6,142 discharged.
 - o 1,941 deaths, up from 1,550.
 - O Different models are projecting different time periods for when the apex will occur.
 - Minimal compliance with social distancing:
 - 110,000 COVID beds.
 - 37.000 ventilators.
 - High compliance with social distancing:
 - 75,000 COVID beds.
 - 25.000 ventilators.
 - o Models also project deaths throughout the country, and the Institute for Health Metrics and Evaluation (IHME) model currently projects New York to lose 16,000 people through July.
 - New testing is available:
 - Regeneron is creating 500,000 test kits at no charge.
 - 25,000 to be delivered per day (deliveries started Monday).
 - Corning has donated 100,000 tubes, and provided an additional 500,000 at reduced cost and expedited deliver.
 - o The State is going to close down New York City playgrounds and leave open spaces available.
 - During press questions, Governor Cuomo confirmed COVID patients were transferred from New York City to Albany Medical Center last night.
 - Asking hospitals Statewide to cooperate like never before, including shifting patients.
 - The Governor announced a conceptual budget agreement with the Assembly Speaker and the Temporary President of the Senate, and stated members of the legislature are being briefed.

Federal News Updates

March 31, 2020

- President Trump and the Coronavirus Taskforce held a press conference and announced the following:
 - o The President announced the federal guidelines have been extended and updated to reflect recent data.
 - o The Treasury Department and Small Business Administration have provided an overview of the Paycheck Protection Program for small businesses that was included in the CARES Act.
 - o Members of the Coronavirus Taskforce briefed the public on the benefits of public mitigation:
 - Estimates if no mitigation, were 1.5 million to 2.2 million deaths
 - Now with mitigation, estimates are 100,000 to 240,000 deaths.
 - IHME model shows peak count of daily deaths is 14 days, with an estimated 2,214 COVID-19 deaths nationwide projected on April 15, 2020. This model is based on current mitigation efforts.
