Bid Opening – Round Mountain Community Gym Floor

Musselman announced the bid from Dynamic Sports Construction. Two quotes. For 6mm system for \$104,760. A 9mm system for a \$109,022. \$13,488 can be deducted from either price if the new floor is installed over the existing. If they add a vinyl wall base it adds \$2,112.

Olmedo explains that Dynamic Sports Construction is the company that came out on site to look at the floor.

Swigart mentioned to open up for a rebid.

Discussion and possible decision to award bid for Round Mountain Community Gym Floor
