From The TNT Team: We Can Handle Your Mailing!

We can take your client database, imprint those addresses on your newsletters, apply our bulk mailing permit, sort, bundle and deliver to the post office. We also run your customer names through the National Change of Address (NCOA) database and inform you if any have changed their address. All of these services, including postage, are the cost of a first class stamp to you.

As an example, if your subscription is 200 pieces and your mailing list is 175 names, we will mail the 175 pieces for you at \$0.49/each, and drop ship the remaining 25 pieces to your shipping address.

Lock In 2015 Prices and Renew Your 2016 Subscription Now

We are trying to hold the line on pricing for 2016, but UPS shipping rates have (once again) increased dramatically, making it difficult. If you place your order for 2016 this year (before December 31, 2015), you will avoid any potential price increase. We can negotiate favorable rates with UPS by pre-paying for their services, hence the reason to push for renewals before year end. UPS Shipping Update

UPS will typically leave a delivery at a RESIDENCE (you should contact your local UPS delivery person to confirm this). UPS will **not** leave a delivery at a BUSINESS unless they have a signature on file that allows them to leave the delivery **or** you have made prior arrangements. Again, check with your local UPS delivery person.

Tax News & Tips will charge for any undeliverable packages, since they get returned to us and then we have to re-send them, essentially tripling our shipping costs. Be sure to make arrangements with your local UPS delivery person to avoid these additional charges.
