ONLINE PRIVACY POLICY AGREEMENT

This Privacy Policy ("Policy") will help you understand how we collect and use personal information from those who visit our website or make use of our online facilities and services, and what we will and will not do with the information we collect. Why We Collect Information and For How Long

We are collecting your data for several reasons:

Use of Information Collected

Fusion4Athletes does not now, nor will it in the future, sell, rent or lease any of its customer lists and/or names to any third parties.

Fusion4Athletes may collect and may make use of personal information to assist in the operation of our website and to ensure delivery of the services you need and request. At times, we may find it necessary to use personally identifiable information as a means to keep you informed of other possible products and/or services that may be available to you from https://fusion4athletes.com

Fusion4Athletes may also be in contact with you with regards to completing surveys and/or research questionnaires related to your opinion of current or potential future services that may be offered.

- to outside auditors who have agreed to keep the information confidential;
- as necessary to enforce the Terms of Service;
- as necessary to maintain, safeguard and preserve all the rights and property of Fusion4Athletes.

Non-Marketing Purposes

Fusion4Athletes greatly respects your privacy. We do maintain and reserve the right to contact you if needed for non-marketing purposes (such as bug alerts, security breaches, account issues, and/or changes in Fusion4Athletes products and services). In certain circumstances, we may use our website, newspapers, or other public means to post a notice.

Children under the age of 13

Fusion4Athletes's website is not directed to, and does not knowingly collect personal identifiable information from, children under the age of thirteen (13). If it is determined that such information has been inadvertently collected on anyone under the age of thirteen (13), we shall immediately

Notice to European Union Users
