

# KENTUCKY ASSOCIATION OF CONSERVATION DISTRICTS

## OUTSTANDING CONSERVATION COOPERATOR AWARD

**AWARD PROGRAM:** Through this program, KACD intends to honor and recognize farmers who are taking the initiative to implement sound, innovative and cost-effective conservation techniques and best management practices. The state winner(s) are selected on the basis of accomplishments in soil and water resource management and pollution prevention. The state winner and runner-up will each receive an award certificate and a \$500 cash award for first place and \$250 for second. In addition, conservation districts with first or second place winners would receive a plaque.

**PARTICIPATION:** Nominee must be a "Master Conservationist" and the application submitted by their local conservation district. The district shall describe how the farmer has integrated sound, cost-effective and innovative conservation practices into their total farming operation. The entire operation, including livestock and property that is owned, rented, or operated by the nominee, must be considered in the application. Also, the district shall describe how the farmer has demonstrated to others how to better use and protect our soil and water resources. State winners from the four previous year's award programs are not eligible for consideration in this year's award program.

A State Selection Committee will be named by the Board of Directors of KACD composed of public and private conservation agencies and organizations. **The nomination application must be submitted to KACD by June 1.**

3. To what extent has the nominee's farm operation been used to demonstrate to other members of the community the problems and solutions associated with soil and water conservation?

**INDIVIDUAL INITIATIVES: (20 POINTS)**

4. Describe areas where the nominee has used their own initiative to develop other resources such as wildlife, woodland or techniques developed by the nominee to implement conservation practices.
