SMHI CROP REPORTS-HAIL INSURANCE 2017

It's that time of year again! If you have not withdrawn from SMHI, you will be receiving your Crop Report at the end of May. Please fill it in and return it to the office by June 15, 2017. **Please Note:** if you have not withdrawn from SMHI as of March 31, 2017, it is legislated that you must insure your crop. If you rent your land out, please write "CASH RENT" on each quarter section, sign it and return it to the office.

FIRE CALLS – FALSE ALARMS:

All preventable false alarm fire calls, where the department is dispatched will be charged to the rate payer at a cost of \$250.00.

WATER WELL TOKENS:

The RM has two wells located within the Municipality boundaries, and one shared well located within the RM of Reciprocity. To access the two wells located at:

1. SW 17-05-03 W2M, and
2. SE 01-06-02 W2M

Come into the office and pick up water tokens. The charge for this valuable service is \$40/year for residential usage (rate payers only), and \$100/year for commercial usage.

DEBIT TERMINAL:

The office has an interact terminal! Rate payers may pay any invoices, taxes, fees etc. using their **debit card**. Unfortunately, because of costs, the RM is **unable** to take credit cards or global payment cards.
