### Approval of the November 26, 2019 agenda

Olmedo explains that the decision to put this on the agenda came after a conversation with a UNR student who was given the town to research. One of the questions was 'what is your town motto' and we don't believe we have one.

Just see how this first one goes then maybe do it more often. Olmedo suggests kicking off January 2020. Enzi mentioned taking pictures now to compare.

Spivey motioned to approve. Enzi seconded; motion passes 4-0. Contest is approved with a date to be decided on at a later time.
