DEPOSITS are NON-REFUNDABLE: By submitting this contract and entering your credit card information you are authorizing Bacon Enterprises. to charge the credit card for any of the following charges, cash/check also accepted; deposit, damages to the vehicle, and all services rendered. **Leaving the actual balance due 14 days prior to the event.** If you book under 14 days, then the balance is due in full. **WE PAY THE TAXES.**

CONTRACT OBLIGATIONS: I understand and agree to the length and usage along with any charges and further agree to pay for any and all damages my party may incur. I also agree to the above Charter bus Rules and Regulations and by signing verify that I have read and received all pages (2 pages) of the contract. All damages are the sole discretion of the driver and Bacon Enterprises. I understand and agree to pay the entire contract price if the cancellation policy is not followed. The number of hours agreed to on the contract are the minimum hour's customer agrees to pay.

ALTERED OR INCOMPLETE CONTRACTS

Altered or incomplete contracts cannot be accepted by Bacon Enterprises.

DEPOSIT & CANCELLATION POLICY

We require a \$200.00 non-refundable deposit for each booked event. To secure the date the entire bill must be paid in full 14 days prior to the event or the card below will be charged, plus a 4% service fee. Any charter cancelled within 30 days or less will be charged the full amount. Cancellation must be sent via email (baconpartybus@gmail.com), AND a phone call to (605-725-1145).

SMOKING

All of our vehicles are non-smoking. A \$100 fee will be assessed for each cigarette smoked, this also refers to vape devices.

DRINK SPILLS

There is a \$50.00 clean up fee for each drink spill that leaves a stain.

MISSING ITEMS

Bacon Enterprises will charge the client for any missing items based on their replacement cost plus 25%.

DAMAGES

The client will be charged for any damages that are caused by the client or their patrons that occupy our properties. The client will also be charged nominal fees for loss of business during damage repair time. The Client is responsible for any damages/missing property of the property during the contracted times. The only exception to this clause is an act of God or from the employee. This clause is to include, but is not limited to torn seats, excessive soil or dirt, broken fixtures, spilled liquids, vandalism, or missing items (a cleanup fee of \$300 will be assessed for excessive cleaning). The Client agrees to be responsible for any damages to be paid for within seven days of such occurrence and will be held responsible for any incidental or consequential damages to include, but not limited to vehicle rentals or downtime. Bacon Enterprises will add a fee of 25% to any costs incurred.

CURRENT CHARGES FOR DAMAGES

1. Broken Glassware... \$25 per broken item.
2. Vomiting, Urinating or Feces contamination of Vehicle... \$300 minimum
3. Interior Tears, Holes, Burns, Stains... \$200 minimum or est. amount to replace/repair
4. Acts of Vandalism or Excessive Damage... \$200 minimum or as determined by professional damage report.
5. Smoking in Vehicle by Client OR Guests... \$100 minimum per cigarette, pipe, cigar, vape or anything deemed to be as such.

In the event Bacon Enterprises is unable to perform to the terms of this agreement, the maximum liability is to refund all monies paid by the Client; in no event shall Bacon Enterprises be held liable for any incidental or consequential damages. Any act considered one of "God or Government" does not make the Client eligible for a refund. This is to include police, military, or EMS obstruction, natural disaster, impassable weather or traffic, or any amount of snow. Such impassable weather or traffic does not allow the Client to receive additional hours of coverage or transportation. While Bacon Enterprises will make every attempt to accommodate the request of specific vehicles, no guarantee as to specific individuals can be made. In the event a replacement vehicle is to be used, Bacon Enterprises guarantees it to be appropriately sized vehicle(s) to accommodate the Client's guests.

COVERAGE

Coverage runs within 25 miles of Aberdeen. You may go further for \$50/75 per 25 miles out depending on vehicle. If you run over your specified time (above) charges apply in 30 min increments. Please call or ask the driver for details.

PERSONAL ITEMS

Bacon Enterprises is not responsible for items left behind. Double-check the vehicles at the end of your run. If an item is left behind please contact us immediately.

CHAUFFEURS DISCRETION

The charter may be cancelled at any time for any reason. Partial or full refunds are possible depending on the reason.

ALCOHOL

No alcohol will be consumed by any passengers under the legal age of 21. If this does occur, the charter will be terminated immediately, no refund will be given.

ILLEGAL DRUG USE

Illegal drugs are not allowed on the property of Bacon Enterprises. If illegal drugs are found it will result in immediate termination of the charter and no refunds.

RESPONSIBILITY OF CLIENTS & THEIR PATRONS

While we want all of our clients to have the best time possible, all clients & their patrons need to know their tolerances to alcohol, general safety & well being is our main concern. We reserve the right to terminate any charter at any time if we feel that the safety, health or general well being of any client or their patrons is being compromised.

CLIENT AGE

Signing client must be at least 21 years of age. **A current ID must be available upon request from all patrons.**

TRANSPORTATION OF MINORS

Any persons under 21 are the responsibility of contract signer and Bacon Enterprises is not liable for underage alcohol consumption. Please refer above under the "alcohol" description. If a minor is caught consuming, there will be a \$1000.00 fee assessed.

RETAINERS

The charter may be cancelled at any time if one or more terms and or conditions of this contract are breached. No refunds will be given for any charter that is terminated for any of the previously mentioned reasons.
