Top Rule: Create and attractive and inviting booth and give everyone an honest smile!

The following terms and conditions define the agreement between you as the VENDOR and Solace Farms General Store:

Unfortunately, we must include the rest of this information. Participating in the show is contingent on agreeing to, as well as adhering to, all local laws and regulations in addition to ALL of the following:

- 1. LAWS, RULES AND REGULATIONS: All pertinent fire codes, laws, ordinances and regulations pertaining to health, fire prevention and public safety shall be strictly obeyed.
- 2. RELEASE AND HOLD HARMLESS AGREEMENT: The request to reserve vendors space constitutes an express contractual agreement between myself, my partner and/or employee(s) and Solace Farms General Store and it is understood and agreed that by signing this agreement I fully and finally release and hold harmless both Solace Farms General Store, its agents, and employees, and the Town Of Davis, and its agents and employees from any and all liability for any and all claims of every nature and kind whatsoever, including death, personal injury, loss, theft, or damages to personal property, whether or not caused by Solace Farms General Store or The Town of Davis own negligence or the negligence of their agents and employees.
- 3. CONTENT OF BOOTH: Please ensure that your booth is professionally and/or attractively presentable, free of the possibility of injury or breakage and draws LOTS of attention! In addition, Solace Farms General Store reserves the right to approve the contents and character of all exhibits and reserves the right to prohibit or expel any merchandise that is out of keeping with the character of the show. Adult items, or items not intended for family viewing are to not approved DFM items and should not be in public view. The VENDOR agrees to keep all merchandise, chairs and other equipment within the marked boundaries of the booth.
- 4. CREDIT CARDS: Vendors renting space will handle all sales independently. An ATM is available inside The Davis Bar for shoppers to receive cash.
- 5. SD SALES TAX: ALL Sales taxes collected will be paid by the Vendor to the State of South Dakota as required. Flea Market Vendors are required to collect and pay 8% sales tax which includes SD sales tax of 4.5%, Davis municipal tax of 2%, and tourism tax of 1.5%.  Per South Dakota guidelines, all vendors are required to complete SD Tax form (attachment A) and also located at: https://www.state.sd.us/eforms/secure/eforms/E1934V8-SalesReturn.pdf
- 6. PAYMENT/CANCELLATION POLICY: To reserve a space, application and payment must be received and approved at least 2 weeks prior to the Flea Market. Full payment is required and will not be adjusted for less days/time of set up. Vendors that are unable to attend after payment is made will not receive a refund of the booth/table rent, however may request to apply it to a later date.
- 7. FLEA MARKET HOURS: Early buyers are allowed during set up times. Flea Market Hours are Saturday 8am 4pm. **Vendors are able to stay set up later than the 4pm time and encouraged to maximize this opportunity!** We ask vendors to not begin packing or to

bring in dollies or hand trucks until after 4pm. We prefer that Vendors do not set up the evening prior, and the vendor assumes all liability should they choose to do so.

- 8. "Drop In" vendor's payment for booth / table rent will require approval to set up and must be paid at Solace Farm prior to setting up for the event. "Drop In" vendors will be charged \$50.00 for Booth Rent *if approved* for each 12'x12' space.
- 9. PARKING: In order to accommodate shoppers, must move their vehicles to the post office or grain elevator areas after off-loading. Parking is available near the elevator for trailers and large vehicles.
- 10. BOOTH SHARING: Subletting or donation of space partially or in its entirety is not permissible without the consent of Solace Farm.
- 11. PETS: If you bring a pet to the Flea Market, you assume <u>all responsibility</u> for the pet and any damage it may cause. Please clean up after your pet and keep away from people if the pet is not social and friendly.
- 12. Community and support amongst our Vendors is of the highest importance! We are all here to have fun doing what we love, and while we are neighbors will help each other out as neighbors. Respect, a positive attitude accompanied with laughter and a smile will go a long way to create return customers and word of mouth advertising! ANY vendor that acts in a rude, disruptive way (without provocation) may be banned from the DFM future events. Please help us to make Davis the HAPPY place it used to be! The Town of Davis allows "open container" during all public events in town and we ask that you DRINK RESPONSIBLY. Music is encouraged and hope that everyone has a fun and profitable experience in Davis!
